FOREWORD

This publication lists reports that are required by boilerplate in the FY 2000-01 appropriation acts. It is organized by appropriation act and lists the section number, the purpose of the required report, both the reporting and receiving entities, and the due date of the report. The number of expenditure line items for each appropriation act and the names of the respective fiscal analysts are also shown.

Several boilerplate reports appear in nearly all of the appropriation acts. These include reports on agency efforts to "Buy American," exceptions granted to the state hiring freeze, internal auditor compliance, and when state spending to units of local governments falls below amounts projected for any quarter.

The Management and Budget Act—Public Act 431 of 1984 as amended—also requires reports. A listing of these reports appears at the end of this document.
