### **LARA Overview**

■ E.O.s 2011-4 & -5 reorganized the Department of Labor, Energy, and Economic growth into LARA. LARA is responsible for:

#### Commercial and Occupational Regulation

Office of Financial & Insurance Regulation, Public Service Commission, Liquor Control Commission, and the Bureaus of Commercial Services, Construction Codes, Fire Services, Health Systems, and Health Professions

#### Employment Services and Safety


Unemployment Insurance Agency, Workers' Compensation Agency, Wage & Hour Division, Commission for the Blind, Michigan Rehabilitation Service, and Michigan Occupational Safety & Health Administration

# **LARA:** Gross Appropriations

Substantial increases in FY 09 & 10 due to Federal stimulus (ARRA) money Substantial decrease in FY 12 due to reorganization of DELEG into LARA



FY 2011-12 GF/GP Total = \$8,456,732,800\*





Numerous state restricted funds (from regulatory fees) constitute 48% and various federal grants constitute 44% of revenues for the budget



# **LARA Appropriations**

Employment Services (53% is federal funds for UIA), Department Grants and Occupational Regulation together constitute 69% of LARA appropriations


#### FY 2011-12 LARA Budget = \$858,818,000



# LARA GF/GP Appropriations

Departmental Grants (36%), Rehabilitative Services (19%), Workers' Compensation Administration (14%), Commission for the Blind (13%), and Bureau of Health Systems (11%) constitute 93% of GF/GP appropriations



# **LARA Sources of Funding**

#### **State Restricted Revenues**

Primarily comprised of licensing & permit fees levied on organizations & occupations regulated under LARA agencies & commissions. Also includes public utility assessments, revenue from wholesale liquor sales & other statutory funds.

#### **Federal Revenues**


Primarily comprised of grants from the Departments of Labor, Education, and Health & Human Services with additional grants from the Departments of Energy, Transportation, and Homeland Security.

#### **General Funds**

Constitute less than 4% of LARA's funding


# Departmental Administration

Appropriation funds the salaries of various appointed Commissioners, the LARA Director, and the operation and administration of the offices of Communications, Human Resources, Policy & Legislative Affairs, and Finance & Administrative Services, Also covers expenses for property management, rent, workers' compensation, and special project advances.



# Office of Financial & Insurance Regulation


Appropriation funds the operation and administration of the Office of Financial & Insurance Regulation which is responsible for all of the state's financial regulatory activity; including the oversight of banks & trusts, credit unions, consumer finance services & education, the securities industry, the mortgage industry, receiverships, insurance companies, health maintenance organizations, and BC/BS.

# Public Service Commission & Energy Systems


Appropriation funds the operation and administration of the quasi-judicial Michigan **Public Service Commission** which regulates the production and distribution of investorowned electric and natural gas utilities in addition to certain telecommunication and motor carrier services. Also funds the Metropolitan Right-of-Way Oversight Authority which coordinates public RoW issues involving telecom providers.



## **Liquor Control Commission**


Appropriation funds the operation and administration of the Liquor Control Commission which is empowered to enforce all liquor laws and regulate the traffic of alcohol within the state, including the licensing of vendors of alcoholic beverages and exclusive wholesaling of liquor. The Commission promulgates rules, administers hearings, and sets liquor prices and licensing fees.

Liquor Control Commission Sources of Funding FY 2011-12 Total = \$18,399,300




# **Occupational Regulation**

Appropriation funds the operation and administration of the Bureaus of Commercial Services, Construction Codes, Fire Services, Health Professions, and Health Systems. The bureaus manage various regulatory programs which license numerous occupations and organizations and certify physical & mechanical structures.




# Michigan Occupational Safety & Health Administration

Appropriation funds the operation and administration of the Michigan Occupational Safety & Health Administration which supplants federal OSHA in developing and regulating state-wide occupational health & safety standards and ensuring employer compliance through data collection, workplace inspections, and educational programs and materials.




# **Employment Services**

Appropriation funds the operation and administration of the Unemployment Insurance Agency, Workers' Compensation Agency, Wage & Hour Division (enforces wage/benefit laws), and Bureau of Employment Relations (mediates labor disputes) in addition to the Commission for the Blind and Michigan Rehabilitation Services which provide employment training for the visually and physically disabled.




# Michigan Administrative Hearing System

Appropriation funds the operation and administration of the Michigan Administrative Hearing System which centralizes the administrative hearing functions for several state departments in addition to the Michigan Tax Tribunal, Workers' Compensation Board of Magistrates, and Michigan **Compensation Appellate** Commission. Also funds the Office of Regulatory Reinvention.




# Information Technology

Appropriation funds LARA's payments to the Department of Technology, Management & Budget (DTMB) for information technology services provided by DTMB as part of the administration of LARA's programmatic responsibilities.



## **Department Grants**

Appropriation funds grants administered by LARA, including: vocational rehabilitation, independent living, fire protection, lowincome energy assistance and efficiency\*, liquor law enforcement, remonumentation, subregional libraries, utility consumer representation, and youth low-vision grant programs.



### **Specific Departmental Grants**

#### **Grants Supported with General Funds**

- Grants to CILs for Personal Assistance Services
- MRS grants for Vocational Rehabilitation Customer Support
- Grants to CILs for Independent Living
- Grants to 12 subregional libraries for services to the blind and physically handicapped

### 2011 PA 275

Department Grants include \$23,000,000 supplemental (\$13,000,000 from the Vulnerable Household Warmth Fund and \$10,000,00 from the General Fund) appropriated by 2011 PA 275 to partially replace the Low Income Energy Efficiency Fund (LIEEF) which was invalidated by a Court of Appeals ruling issued on July 21, 2011. The LIEEF was originally appropriated \$95,000,000 for FY 2011-12, \$23,000,000 of which was granted by the MPSC to nonprofit organizations for energy assistance programs. Following the invalidation of the LIEEF by the Court of Appeals, potential contributions to the LIEEF were deposited into escrow accounts and unexpended grant amounts were refunded. 2011 PA 275 appropriated \$23,000,000 to LARA to fund the energy assistance grants made to nonprofit organizations. Please note that the \$23,000,000 is not actually in addition to the original \$95,000,000 appropriation, but a partial replacement of it.

# SB 863 (S-1)

LARA's FY 2011-12 appropriation includes supplemental of \$24,327,600 Gross (\$1,496,600 in IDG, \$11,787,300 in federal, \$10,092,400 in state restricted, and \$951,300 in GF/GP) appropriated by SB 863 (S-1) to prefund Other Post Retirement Benefits (OPEB) based on the number of FTEs throughout LARA.
