RE: Revenue Sharing Payments to Local Units

Public Act 168 of 2003 amended the Revenue Sharing Act by changing the distribution mechanism for FY 2003-04 so that each local unit's revenue sharing payment will be reduced by 3% from its 2002-03 fiscal year payment. As a result, total revenue sharing payments will decline by \$43.5 million. In the event that sales tax revenues do not meet the projected estimates, the percentage reduction will be increased.

The following table summarizes the distribution of final revenue sharing payments for FY 2002-03 and the enacted appropriation for FY 2003-04, along with the corresponding dollar and percentage changes.
