A bill to amend 1979 PA 94, entitled

**(1) The fiscal year 2022-2023 operation funding amounts in section 201(2) (a) to (bb), not including amounts for North American Indian tuition waiver reimbursements, are based on the formula in subsection (2). As used in this section:**

**(a) "Base operations amount" means an amount equal to 75% of the prior fiscal year's total operations appropriation not including any appropriation for North American Indian tuition waiver reimbursements, less 1-time operations appropriations, plus an operations appropriation increase for the current fiscal year not including any appropriation for North American Indian tuition waiver reimbursements.**

**(b) "FYES average" means a community college's average number of fiscal year equated students for the 3 prior fiscal years.**
