## **MINUTES**

## House Appropriations Subcommittee on Community Colleges March 30, 2017

Room 352, Capitol Building

The subcommittee was called to order at 10:31 a.m. by Representative Afendoulis, Chair. All members were present.

Representative Marino moved to adopt the minutes of March 2, 2017 and March 13, 2017. The minutes were approved without objection.

Representative Marino moved to place the House Substitute for House Bill 4236 (H-1) Draft 2 before the subcommittee. The motion was approved by a vote of 7-0-0.

Perry Zielak, Fiscal Analyst, House Fiscal Agency provided a brief overview of HB 4236 (H-1) Draft 2, the FY 2017-18 Community Colleges budget.

Representative Rabhi moved to amend the bill as follows:

- 1. Amend page 2, line 15, by striking "\$395,142,600.00" and inserting "\$245,142,600.00"
- 2. Amend page 2, line 17, by striking "\$0.00" and inserting "\$150,000,000.00"
- 3. Amend page 5, line 26, by striking **\$15,892,000.00** and inserting **\$165,892,000.00**
- 4. Amend page 6, line 1, by striking "\$0.00" and inserting "\$150,000,000.00"

The amendment was not adopted, the members voting as follows:

Representative Yanez moved to amend the bill as follows:

- 1. Amend page 2, line 17, by striking "\$0.00" and inserting "\$2,000,000.00"
- 2. Amend page 6, following line 24, by inserting: "(7) FROM THE APPROPRIATIONS DESCRIBES IN SUBSECTION (1), SUBJECT TO 1986 PA 102, MCL 390.1281 TO 390.1288, THE AMOUNT APPROPRIATED FOR A PILOT OF INDEPENDENT PART-TIME STUDENT GRANTS IS \$2,000,000.00, APPROPRIATED FROM GENERAL FUND/GENERAL PURPOSE MONEY. IF THE NUMBER OF ELIGIBLE APPLICANTS EXCEEDS THE MONEY AVAILABLE, PRIORITY SHALL BE GIVEN TO PERSONS WITH THE GREATEST FINANCIAL NEED AS DETERMINED BY EACH EDUCATIONAL INSTITUTION. BEGINNING IN FISCAL YEAR 2018-2019, A COMMUNITY COLLEGE SHALL REPORT, IN A FORM AND MANNER DIRECTED BY AND SATISFACTORY TO THE DEPARTMENT OF TREASURY, BY OCTOBER 15 OF EACH YEAR, ALL OF THE FOLLOWING:
- (A) THE NUMBER OF STUDENTS IN THE MOST RECENTLY COMPLETED ACADEMIC YEAR WHO RECEIVED AN INDEPENDENT PART-TIME STUDENT GRANT AT THE COMMUNITY COLLEGE.
- (B) THE NUMBER OF STUDENTS IN THE MOST RECENTLY COMPLETED ACADEMIC YEAR WHO RECEIVED AN INDEPENDENT PART-TIME STUDENT GRANT AT THE COMMUNITY COLLEGE AND SUCCESSFULLY COMPLETED A CERTIFICATE OR DEGREE PROGRAM.

(8) BEGINNING IN FISCAL YEAR 2018-2019, IF A COMMUNITY COLLEGE FAILS TO REPORT THE INFORMATION REQUIRED IN SUBSECTION (7), THE DEPARTMENT OF TREASURY SHALL NOT AWARD INDEPENDENT PART-TIME STUDENT GRANTS TO OTHERWISE ELIGIBLE STUDENTS ENROLLED AT THE COMMUNITY COLLEGE. THE DEPARTMENT OF TREASURY SHALL REPORT THE INFORMATION REQUIRED IN SUBSECTION (7) TO MEMBERS OF THE SENATE AND HOUSE APPROPRIATIONS SUBCOMMITTEES ON COMMUNITY COLLEGES, THE SENATE AND HOUSE FISCAL AGENCIES, AND THE STATE BUDGET DIRECTOR BEFORE NOVEMBER 1 OF EACH YEAR."

The amendment was not adopted, the members voting as follows:

Nays: Reps. Afendoulis, Marino, Bizon, Brann

Pass: None

Representative Marino moved to report the House Substitute for HB 4236 (H-1) Draft 2 of the subcommittee and refer it to the House Appropriations Committee with recommendation that it pass.

The motion was adopted 4-0-2, the members voting as follows:

Nays: None

Pass: Reps. Yanez, Rabhi
