# **BPL** Overview

- Established in July 2015
- MI Public Health Code, PA 368 of 1978
- MI Occupational Code, PA 299 of 1980
- 10 Occupational Boards
- 25 Health Professional Boards
- 3 PHC Committees (HPRC, PDOAC, MMRP)
- Boards are advisory and determine sanctions
- License and regulate over 758,000 individuals




# **BPL** Overview

- Administer the Health Professional Recovery Program (HPRP)




### **BPL Active Health Licenses**










### ACTIVE OCCUPATIONAL LICENSES BY PROFESSION AS OF 03/06/2017 LESS THAN 15,000

# **BPL Staffing**

- 218 Employees: 205 FTE
- Licensing: 73 Total; 68 FTE
- Enforcement: 38 Total; 35 FTE
- Investigations/Inspections: 56 Total; 53 FTE
- MMP: 25 Total; 24 FTE
- IT/Admin: 7 FTE
- Bureau Admin: 6 FTE



# **BPL FY 2018 Appropriation**

BPL is funded through licensing fees and application fees from each of its licensing programs. All funds are State Restricted and appropriated as follows:

- Health Professional Fund \$23,913,500
- Occupational L&R Fund \$9,157,100
- Additional Funds: Nurse Scholarship and Nurse Education; Occupational Enforcement for Unlicensed Activity; MMP



# **BPL FY 2018 Appropriation**

- \$1,963,800: Nurse Professional Fees (Nurse Scholarships, Nurse Education)
- \$1,851,500: Pain Management Fees (MAPS)
- \$ 643,600: Builder Enforcement Fund
- \$ 704,400: Real Estate Enforcement Fund
- \$ 688,300: Accountancy Enforcement Fund
- \$4,949,100: Medical Marijuana Program



# **BPL 2016 Achievements**

- LPI conducted for each of the Divisions with MMP slated to go through LPI in 2017
- Eliminated backlog of 3,849 emails taking 1 month to respond to responding within 1 business day
- Went from 70% to 100% completion of inspections within 30 days or less
- Improved timeframe to complete OC investigations within 90 days from 29% to 87%



# **BPL 2016 Achievements**

- Timely completed 3,746 FOIA requests
- 10,000 MMP applications received on average per month, 98% processed within 15 days
- Continue to strive to improve and provide better service to customers



# **BPL Current Projects**

- Full replacement of MAPS with Appriss, PMP AWARxE software, implementing new system April 4, 2017
- Replacing licensing and regulatory database system to Accela software, starting with Nursing and implementing in July 2017
