Conservation Reserve Program



History of CRP

- Established under the 1985 Farm Bill on December 23, 1985
- Reauthorized under subsequent Fam Bills
- 1985 Farm Bill Statute is amended with each Farm Bill that enhances or changes CRP
- 1996 Farm Bill authorized Continuous CRP signup for certain high priority environmental practices and the Conservation Reserve Enhancement Program (CREP)
 - As a result 2000 is when Michigan first began enrollment into CREP
- 2002 created State Acres for Wildlife (SAFE)
 - Michigan's first SAFE was rolled out in 2008
- 2014 Farm Bill authorized CRP Grasslands (formerly Grassland Reserve Program)
- 2018 farm Bill, policy is still in pre-decisional stages
- Water Quality is a higher priority- CLEAR Initiative
 New CRP Pilot program CLEAR 30 will be applicable to Michigan
- 2020 will mark 35th anniversary of the program!



Conservation Reserve Program

Increased Water Quality Focus Clean Lakes, Estuaries, and Rivers (CLEAR) practices on CRP.



- · Continuous signup.
- Prioritizes water quality practices such as contour grass strips, filter strips, riparian buffers, wetlands, and a new prairie strip practice.
- 40 percent of total continuous CRP signup acres in CLEAR practices.

Enrollment Authority

- Extended CRP authority to 2023
- Enrollment authority increases from 24 million in Agency 2019 to 27 million in 2023.

Continuous CRP Signup

Continuous CRP signup, to the maximum extent practicable, enroll and maintain not fewer than 8.6 million acres than September 2023

FSA-is the Administrator of the CRP


 Basic eligibility determinations (land and participant), contract approval and administration (included issuing annual payments, cost-share and incentives) and compliance

NRCS is responsible for all technical aspects of the CRP.

 Needed, suitability, and feasibility determination, conservation plan development, practice certification, and status reviews
 Note: NRCS utilizes other trained conservation partners such as Conservation District staff when needed.
