1. JOINT CAPITAL OUTLAY SUBCOMMITTEE RULES FOR 2009-2010

2. <u>STATE BUILDING AUTHORITY LEASE AGREEMENTS – SENATE CONCURRENT RESOLUTION 5</u> DMB Letter Date: 1/22/09

The State Building Authority (SBA) requests Legislative approval of a concurrent resolution that would convey property and approve a lease between the State, the SBA and Muskegon Community College for the Student Services One-Stop Center project authorized for planning and construction in Public Act 278 of 2008 and House Concurrent Resolution 98 of 2008. Approval of the resolution would allow bonds to be sold to finance project construction.

An overview was provided by Bill Bowerman, Senate Fiscal Agency. This project involves renovation of existing space to consolidate all student services, including registration, records, counseling, testing career services, student placement, recruitment, financial aid, and student life. These student services functions will be on one level in a prominent location adjacent to the lobby of the main building. This One-Stop Center began as a college self-funded project and has been expanded to include nursing

classrooms and other student support areas. The total cost of the project is \$5.0 million and the State share is \$2.5 million. Annual rental payments to the SBA are estimated at \$171,000 to \$224,000 until the bonds are retired (approximately 15 to 17 years).

The resolution would convey property and transfer title of the facility to the SBA. Approval of the lease agreement sets up a contractual obligation between the State and the SBA requiring the State to make rental payments to the SBA. The SBA will use the rental payments to pay off the bonds sold to finance construction. Once the debt obligations are satisfied, the SBA will transfer title back to the institution. The estimated annual rental amounts are provided pursuant to the requirements of the State Building Authority Act. A true rental amount will be determined by an appraiser once the building is complete.

3. <u>FY 2008-09 CAPITAL OUTLAY SUPPLEMENTALS AND NATURAL RESOURCES TRUST FUND APPROPRIATION BILL</u>

DMB Letter Date: 2/12/09

Bill Bowerman, Senate Fiscal Agency, provided an overview of Senate Bill 322. On December 4, 2008, the Michigan Natural Resources Trust Fund Board made its annual recommendations for acquisition and recreation development projects to be funded from the Natural Resources Trust Fund. The Board recommended 37 acquisition projects and 44 development projects, totaling \$48.5 million. A list of all of the Board's recommendations is included in the bill analysis. Appropriations for these projects are usually enacted in a supplemental appropriations bill in the spring. The Governor's February 12, 2009 supplemental recommendation includes funding for the Trust Fund Projects, along with Federal funding for Waterways Projects and Federal Funds for Military Affairs (Camp Grayling).

Senator Kahn introduced Eric Rutherford of Bridgeport Township, who testified regarding the process for awarding Natural Resources Trust Fund grants, specifically in relation to the Liberty Park Improvement Project. Testimony regarding general support of the Trust Fund Appropriation was provided by Dennis Schornack, representing the Michigan Recreation and Park Association, and Rachel Kuntzsch representing Heart of the Lakes.
