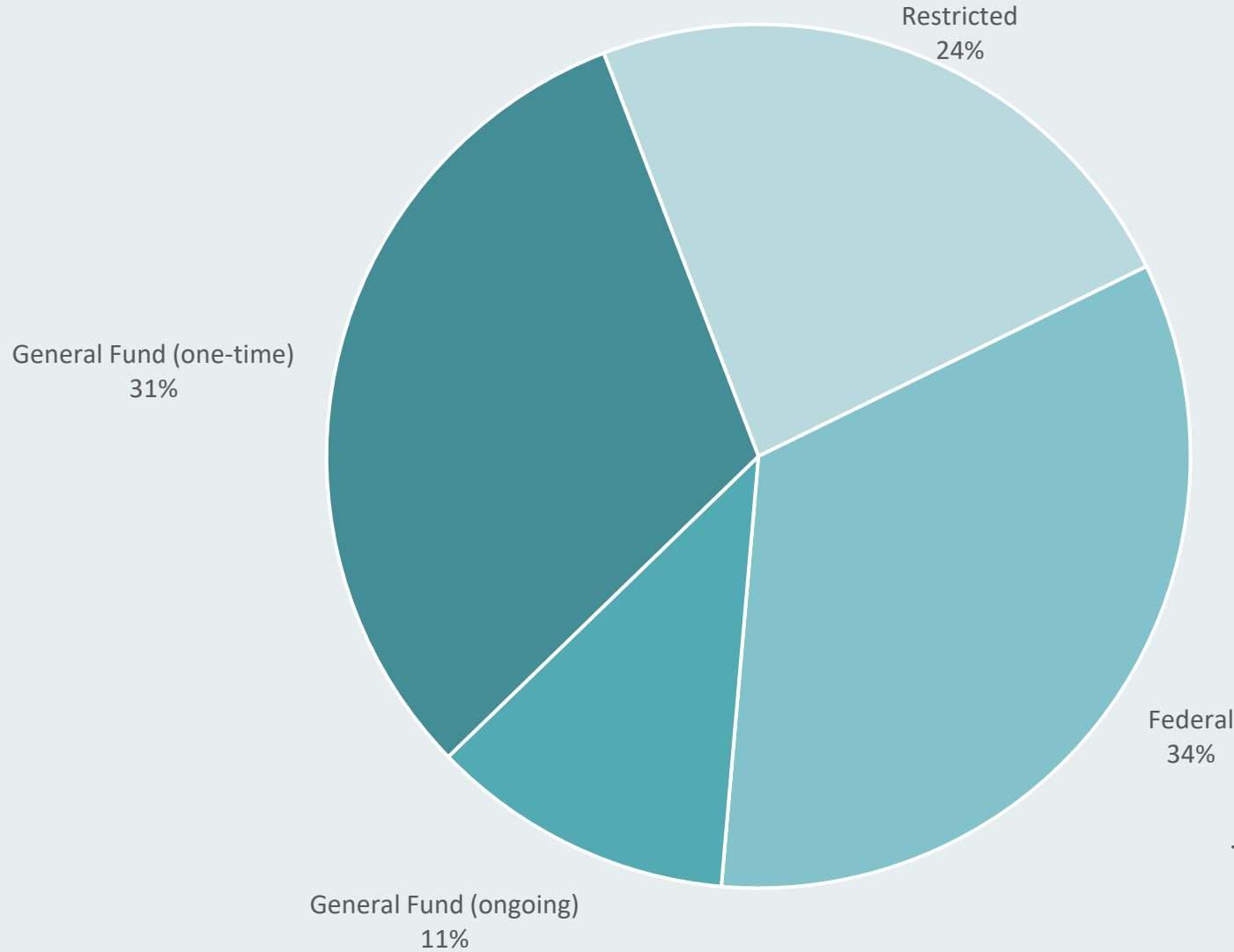

Infrastructure

- \$280.5 million for water infrastructure
- \$225.7 million lead service line replacement
- \$25 million dam grants
- \$10.3 million for orphan well remediation

Improving Service to the Public

- Modernization and permitting
- 65 FTEs
- \$6.6 million ongoing general fund to improve capacity and customer service



Climate and Energy

- \$40 million renewable ready communities
 - \$15 million critical mineral recycling research hub
 - \$8.5 million propane resiliency enhancement

Groundwater

- Environmental Justice
 - Historically disadvantaged, underrepresented, and overburdened communities
 - Contaminated Site Cleanup
 - Air Pollution Control or Mitigation
- Groundwater
 - \$23.8 million groundwater data collection and management
 - \$680,000 for regulating groundwater discharges



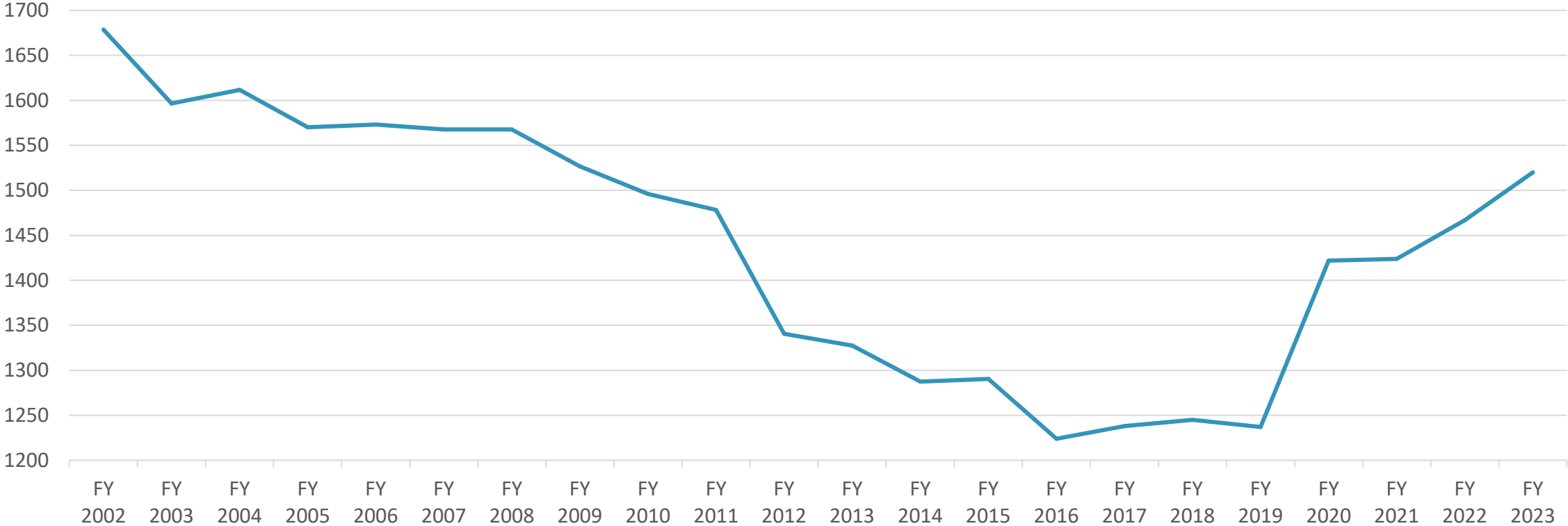

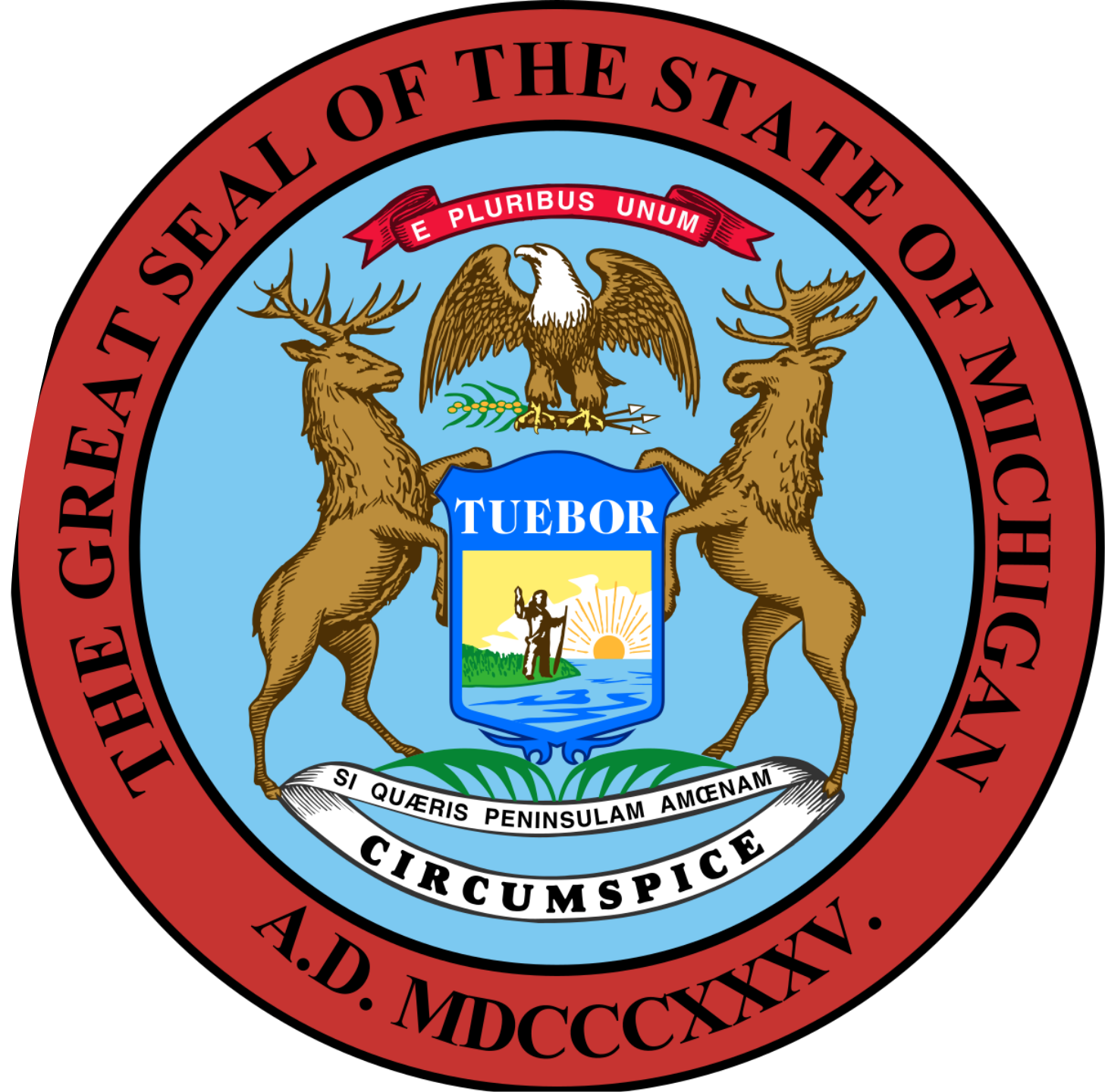
