RE: EGLE Fees

There are currently 64 fees whose revenue supports the Department of Environment, Great Lakes, and Energy (EGLE), 47 of which have no sunset. The remaining 17 fees are scheduled for sunset in 2023 (seven) or 2025 (ten). Each fee title, rate, sunset, and annual revenue is listed below:
