#### A. OVERVIEW

In FY 2011-12, the Higher Education budget was merged into the compiled State School Aid Act (as Article III of that act), rather than being enacted as a standard one-year budget bill. The FY 2023-24 budget continues the practice of including the Higher Education budget in the School Aid Act. The House and Senate used separate vehicle bills to develop the FY 2023-24 budget. The House version of the budget was contained in House Bill 4304. The Senate version of the budget was contained in Senate Bill 200. The enacted version of both the Higher Education and Community Colleges budgets were contained in Senate Bill 173.

Senate Bill 173 also contained a FY 2022-23 supplemental appropriation that included a one-time Michigan Public School Employees Retirement System (MPSERS) unfunded actuarial accrued liability (UAAL) payment of \$200.0 million School Aid Fund (SAF) and an increase of \$2.5 million federal Temporary Assistance for Needy Families (TANF) for the Tuition Incentive Program (TIP).

Senate Bill 174 was used as a FY 2023-24 supplemental bill that amended the Infrastructure, Technology, Equipment, Maintenance, and Safety (ITEMS) certification process and Michigan Achievement Scholarship Program eligibility.

#### **B. UNIVERSITY OPERATIONS: OPERATIONS FUNDING**

Operations funding for Michigan's 15 public universities typically includes three components: base funding, the operations increase, and North American Indian Tuition Waiver (ITW) funding. Base funding is the university's operations appropriation from the prior fiscal year without ITW funding. Increased operations funding is added to the base funding level and has been distributed in an across-the-board method in recent years. Further detail about ITW funding can be found in the next section.

The FY 2023-24 budget provided an overall ongoing operations increase of 6.4%. This increase was determined between two distribution methods: an ongoing increase of 5.0% for universities distributed across the board, and an additional amount for universities that received less than \$4,500 per fiscal-year-equated student (FYES) in FY 2022-23. The FYES payment was based on the amount necessary to increase each university's ongoing operations amount to \$4,500 per FYES over two years. Three universities received additional FYES funding: Grand Valley State University, Oakland University, and the University of Michigan-Dearborn.

The FY 2023-24 budget formally repealed the university performance funding formula. The performance formula was used between FY 2012-13 and FY 2019-20 to allocate year-over-year funding increases to universities based on performance metrics. The performance funding increases would typically be rolled into each university's base amount for the subsequent year.

#### **Operations Funding Requirements**

In order to qualify for the funding increase, a university must meet four policy requirements under Section 241c of the budget:

- Comply with tuition restraint requirements, which includes limiting the increase in resident undergraduate tuition and fees for FY 2023-24 to no more than 4.5% or \$676, whichever is greater.
- Certify that the university participates in reverse transfer agreements with at least three Michigan community colleges. A reverse
  transfer agreement allows a student who transfers from a community college to a four-year university and subsequently completes
  sufficient credits to receive an associate's degree to be awarded that degree by the community college.
- Certify that credits earned outside of the university will count regardless of whether credits were earned using dual enrollment, the location of the course, whether the course was online or in-person, or whether the credits were used toward high school graduation requirements.
- Actively participate in, and submit timely updates to, the Michigan Transfer Network, an online service for students that provides
  course transfer equivalencies across all public colleges and universities and most independent colleges and universities in the
  state.

Universities must certify that they have complied with these requirements by the last business day of August of each year. Any funds forfeited due to noncompliance are reallocated to compliant universities in proportion to their funding increase amounts for that year.

In addition, monthly operations payments are/will be withheld from universities that do not submit annual Higher Education Institutional Data Inventory (HEIDI) data; certify compliance with various Title IX, campus security, and sexual assault reporting requirements; and post various institutional reports to a public website and provide them to the House and Senate Higher Education appropriation subcommittees and the fiscal agencies.

#### C. NORTH AMERICAN INDIAN TUITION WAIVERS

In FY 1996-97, funding totaling \$2.4 million was added to university base appropriations for costs incurred by the universities under 1976 PA 174, the waiver of tuition for North American Indians act. Additional funding of \$1.4 million was allocated for this purpose in FY 2007-08, along with an additional \$500,000 that was incorporated into the base funding in FY 2015-16. In FY 2017-18 and FY 2018-19, a separate \$300,000 General Fund/General Purpose (GF/GP) appropriation was included to partially offset the continuing shortfall in state funding for Indian Tuition Waivers (ITWs), but this appropriation was never incorporated into the base funding. For FY 2019-20, an additional \$6.9 million was appropriated to address the entire program funding shortfall for each university. Indian Tuition Waiver program shortfall appropriations were combined with appropriations assumed to be in the base funding and listed explicitly in each university's operations line-item appropriation. Currently, Indian Tuition Waiver payments are adjusted to match the most recent reported waiver cost for each university, as reported to the Michigan Department of Civil Rights. For FY 2023-24, total program funding is \$12.2 million.

<u>Table 9</u> lists, for each university, the FY 2022-23 ITW appropriation, FY 2021-22 ITW reported costs (the most recent reported costs at the time of the budget's creation), adjustments made for FY 2023-24 to align ITW payments with ITW costs, pass-through payments to the tribal institutions, and the FY 2023-24 ITW appropriation to each university.

Additionally, the FY 2023-24 budget increases the ITW pass-through payment to Saginaw Chippewa Tribal College through Central Michigan University from \$31,000 to \$63,200 and increases the ITW pass-through payment to Keweenaw Bay Ojibwa Community College through Northern Michigan University from \$87,800 to \$90,200. These payments are outlined in sections 269 and 270c of the State School Aid Act.

#### D. MICHIGAN PUBLIC SCHOOL EMPLOYEES RETIREMENT SYSTEM (MPSERS)

Since FY 2012-13, the Higher Education budget has provided support for the seven universities (Central, Eastern, Ferris, Lake Superior, Michigan Tech, Northern, and Western) with employees remaining in MPSERS.<sup>2</sup> Since FY 2015-16, the funding allocation has been based on a rate cap on the employer's share of unfunded actuarial accrued liability (UAAL) costs. The Michigan Public School Employees Retirement Act was amended by 2016 PA 136 to establish the 25.73% cap on employer (university) contributions for MPSERS UAAL payments.

The FY 2021-22 budget contained an additional \$384.7 million (\$300.0 million SAF, 84.7 million GF/GP) to reduce the outstanding MPSERS obligations owed by the seven participating universities. A FY 2022-23 supplemental contained in 2023 PA 103 made an additional \$200.0 million SAF payment to further reduce the outstanding MPSERS obligations. The FY 2023-24 budget does not contain a MPSERS UAAL state share payment due to the payments made in FY 2021-22.

#### E. MARTIN LUTHER KING, JR. - CESAR CHAVEZ - ROSA PARKS INITIATIVE

There were no policy changes for the six King-Chavez-Parks (KCP) programs for FY 2023-24. <u>Table 10</u> provides an overview of funding for the \$4.9 million initiative. <u>Table 11</u> lists the dollar amounts allocated from each university's appropriation for the College Day, Future Faculty, and Visiting Professors programs. Amounts for those programs have been adjusted based on operations increases to university operations appropriations.

#### F. MSU AGBIORESEARCH AND EXTENSION

The AgBioResearch and Extension programs operated by Michigan State University provide services throughout the state. The FY 2023-24 budget increases the appropriation amounts for these programs by 5.0%, representing an increase of \$1.8 million (to a total of \$38.5 million) for AgBioResearch and an increase for MSU Extension of \$1.6 million (to a total of \$33.2 million).

#### G. STATE COMPETITIVE SCHOLARSHIPS

Public Act 208 of 1964 created the State Competitive Scholarship program, which provides grants to students who score well on the Scholastic Aptitude Test (SAT) and have demonstrated financial need. The initial FY 2023-24 appropriation for the program is \$26.9 million. Boilerplate language specifies that the award amount is set at \$1,500 for FY 2023-24. Legislative intent language was added restricting scholarship eligibility for students enrolling in college after September 30, 2023, as those students may be eligible for the Michigan Achievement Scholarship. However, until 1964 PA 208 is amended with the same restriction, students will continue to be eligible for the scholarship.

State Competitive Scholarships are funded by \$23.9 million federal TANF and \$2.9 million GF/GP.

#### **H. TUITION GRANTS**

Public Act 313 of 1966 created the Tuition Grant program, which provides grants to students with demonstrated financial need enrolled at Michigan independent colleges and universities. The FY 2023-24 budget set the program's funding at \$42.0 million.

Total awards at any institution continue to be capped at \$5.0 million. No institution reached that cap in FY 2021-22 (the most recent data available), although Baker College and Davenport University have done so in previous years. Boilerplate language specifies that the award amount is set at \$3,000. The Tuition Grant program is funded by \$30.1 million federal TANF and \$11.9 million GF/GP.

#### I. TUITION INCENTIVE PROGRAM

The Tuition Incentive Program (TIP) offers two years of associate's degree tuition (Phase I) and up to \$2,000 at a four-year institution (Phase II) for Medicaid-eligible middle school and high school students who go on to graduate from high school. FY 2022-23 supplemental appropriations contained in the FY 2023-24 budget bill added \$2.5 million to increase program funding to \$73.8 million, funded entirely with federal TANF.

A number of boilerplate changes were made between FY 2020-21 and FY 2022-23 that generally make the program easier to qualify for and extend the window during which a student may use TIP benefits. These include removing the application process and providing that benefits expire 10 years after initial enrollment rather than six years after high school graduation.

#### J. MICHIGAN ACHIEVEMENT SCHOLARSHIP

Public Act 212 of 2022 established the Michigan Achievement Scholarship (MAS), which beginning in the fall of 2023 provides scholarship grant awards to Michigan residents in the graduating high school classes of 2023 and after. The program provides a grant award for payment of tuition and fees for up to five years for students at public and private not-for-profit colleges and universities, and up to three years for students at community and tribal colleges. To qualify, a student must be a Michigan resident for at least a year, must be a full-time student, must apply for all other available gift aid, and must have an expected family contribution of \$25,000 or less, as determined by the student's Free Application for Federal Student Aid (FAFSA).

Grant awards under the MAS are split between what is commonly referred-to as "first dollar" and "last dollar" awards. A first-dollar award is made to a student *before* other grant aid is applied. A last-dollar award is made *after* other grant aid is applied. Because MAS awards may only be applied to tuition and fees, students who receive grants awards from other scholarship programs (such as Pell grants) may not receive the full amount of the last-dollar portion if their other financial aid, in combination with the first-dollar portion of the MAS, exceeds their total tuition and fees.

Maximum annual grant awards for the MAS are as follows:

- For students at four-year public universities, a maximum of \$5,500 (\$2,500 first-dollar and \$3,000 last-dollar).
- For students at four-year private non-for-profit colleges and universities, a maximum of \$4,000 (\$1,000 first-dollar and \$3,000 last-dollar).
- For students at community and tribal colleges, a maximum of \$2,750 (\$1,750 first-dollar and \$1,000 last-dollar).

A student at a four-year public university, community college or tribal college who receives a MAS award is not eligible to receive an award under the Michigan Competitive Scholarship program.

A FY 2023-24 supplemental (2023 PA 320) amended some of the scholarship requirements to address revisions made to FAFSA. A student will need a Student Aid Index of \$30,000 or less (the measure that replaces the expected family contribution) to qualify for the scholarship for the 2024-25 academic year. Students who qualified under the previous expected family contribution level of \$25,000 or less during the 2023-24 academic year remain eligible for the scholarship. Finally, the Department of Treasury is directed to calculate or issue guidance for a revised Student Aid Index level for students with additional siblings attending a postsecondary institution.

#### K. CHILDREN OF VETERANS TUITION AND OFFICER'S SURVIVOR TUITION GRANT PROGRAMS

Total funding for FY 2023-24 for both the Children of Veterans Tuition Grant program established by 2005 PA 248 and the Police Officer's and Fire Fighter's Survivor Tuition Grant program created under 1996 PA 195 remains unchanged at \$1.4 million, funded entirely from the state general fund.

#### L. PROJECT GEAR-UP

Project GEAR-UP is a federally funded grant program intended to increase the number of low-income students who are prepared to enter and succeed in postsecondary education. The project provides financial aid awards for up to four years for students who graduated from Title I high schools and who participated in GEAR-UP programs beginning in middle school. For FY 2023-24, total funding for the program remains unchanged at \$3.2 million of federal funding.

#### M. MPSERS NORMAL COST OFFSET

The FY 2023-24 Higher Education budget included a \$9.1 million School Aid Fund appropriation to reimburse universities for the normal cost increase to lower the assumed rate of return for MPSERS from 6.8% to 6.0%. This is a \$4.5 million increase from the previous fiscal year.

#### N. STATE AND REGIONAL PROGRAMS

Funding for Midwestern Higher Education Compact dues (\$116,800 GF/GP) and Higher Education database maintenance costs (\$200,000 GF/GP) remain unchanged from the previous fiscal year.

#### O. INFRASTRUCTURE, TECHNOLOGY, EQUIPMENT, MAINTENANCE, AND SAFETY

The FY 2023-24 budget appropriates \$79.0 million GF/GP for infrastructure, technology, equipment, maintenance, and safety (ITEMS), which allows universities to repair, improve, or maintain existing buildings, facilities, equipment, and technological and physical infrastructure; address debt; or fund school safety measures. A university is eligible to receive ITEMS funding if it has not received a capital outlay project planning or construction authorization between January 1, 2023 and March 1, 2024.<sup>3</sup> Allocations will be determined based on calculated FY 2021-22 fiscal year equated student (FYES) enrollment.

At the time of the publication of this document, seven universities (Eastern, Grand Valley, Northern, Oakland, Saginaw Valley, University of Michigan-Dearborn, and Wayne State) have received a capital outlay planning authorization, leaving them ineligible to receive ITEMS funding. Additionally, 2023 PA 320 placed conditions on ITEMS funding for the University of Michigan-Ann Arbor requiring that at least \$5.0 million must be spent on costs related to a semiconductor research alliance.

#### P. VARIOUS ONE-TIME PROGRAM APPROPRIATIONS

Additional one-time appropriations were made in the FY 2023-24 budget. Michigan Technological University received \$870,000 GF/GP for the creation of a bachelor of science in nursing program to offset the loss of a four-year nursing program in the western Upper Peninsula with the closure of Finlandia University. \$3.0 million GF/GP is appropriated for the Michigan Geological Survey to develop and construct a new facility at Western Michigan University. \$5.0 million GF/GP will be distributed between the universities for critical incident mapping, based on a proportional share of FY 2023-24 operations funding. Finally, Michigan State University will receive \$30.0 million School Aid Fund for the Engineering and Digital Innovation Center.

#### Q. APPROPRIATION ADJUSTMENT DETAIL

This section of this report details appropriation adjustments for each university and other appropriation items.

#### R. BOILERPLATE REPORTING REQUIREMENTS

The final section of this report provides a detailed list of reports required from public universities and other entities under the FY 2023-24 Higher Education budget article of the State School Aid Act.
