


713 Claims Processed	 In FY21, MVAA VSOs processed 713 claims for Michigan veterans and eligible famil members and realized over \$10.6 million in recoveries. For the 1st quarter of FY22, MVAA VSOs have processed 166 applications and realized over \$3.3 million in recoveries.

75,697 Service Hours Provided	 New in FY22, regional grant approach to better meet veteran needs & connect them to benefits. MI Veteran Coalition (American Legion, VFW, VVA & DAV) currently receive all 10 grants and provide services statewide through this grant to veterans and their families.

57 Counties Utilized	 FY21 grants were awarded to 57 counties with the total grant amount exceeding \$3.3 million. Grant funds resulted in technology upgrades that allowed remote operation of veterar services during the COVID-19 pandemic, emergency relief funding directly to veterans and their families, and many other veteran service provision enhancements.

426 Grant Applications Approved	 Approved 426 grant applications totaling over \$1.3 million in FY21, assisting a combined total of 1,124 veterans and their family members (in the same household). MVTF 65+ Peacetime Pilot Program Launched in January 2022. This program allows 65+ veterans who served in a peacetime era, have at least 180 days of service and were discharged under honorable conditions to apply for emergency assistance.

Investment: MINGSTAP Expansion \$11.5M General Fund/General Purpose

- Proposal is to allow a service member (SM) to transfer their MINGSTAP tuition benefit to a spouse and/or their children. This expanded program will provide a generous, flexible tuition benefit that SMs can decide how best to utilize to meet their individual or family's educational needs.
- Over the past two years MING has been called on in an unprecedented fashion with both COVID and non-COVID related missions. This investment and expansion shows that the state values the entire military family.
- Critical to our recruiting and retention needs. We are starting to observe drops in military recruiting nationally and here in Michigan. The state needs to be responsive in its efforts to implement recruitment incentives to ensure we continue to have the resources necessary to respond to the next natural disaster, health crisis or national defense mission.
- Legislation is needed to allow for this transfer to occur. SB 104 (Hollier) & HB 5184 (Tate) are in committee in each respective chamber, need to have to Governor by April 1 in order for expanded benefit to be available for Fall 2022 semester.


Investment: Selfridge ANGB \$6.1M General Fund/General Purpose

- Many are aware of our ongoing efforts to secure future, next generation aircraft flying missions at Selfridge Air National Guard Base in Macomb County.
- Other states who have been successful in securing new flying missions have demonstrated, through investing state revenue into their airfields, the critical nature these missions play to the state and local economy.
- As we continue to work with our federal congressional delegation and the Department of Defense on this effort, the state's investment of these funds will allow us to continue to make critical investments in addressing past deficiencies identified. Particularly addressing encroachment issues in the clear zones of the runway.

Investment: MVAA & MVH Efforts

Veteran Suicide Prevention Outreach Campaign- \$1.2 Million

- The Governor is proposing an investment for MVAA to conduct a veteran suicide prevention outreach campaign.
- This proposal will provide MVAA with the ability to implement a statewide media campaign supporting the SAMHSA and the USDVA Governors Challenge to address the crisis of veteran suicide by developing a state specific campaign to help reduce and prevent suicides amongst veterans and their families.
- The media campaign will be a one-year campaign which includes television, radio, digital, social media, outdoor ads, tabletop tent cards at businesses and organizations, and direct mailers.

Veteran Cemetery Feasibility Study- \$250,000

- Builds on the initial analysis conducted last FY by allocating funds to conduct a professional feasibility study to determine the need and next steps to consider related to the establishment of one or more state veteran cemeteries here in Michigan.
- Michigan is one of only a few states that does not have a state veteran cemetery (MVH at Grand Rapids cemetery does not qualify for the federal program).
- If the state decides to pursue this endeavor the feasibility report will provide us with a roadmap for success.

MVH Transition Funding-\$10 million

- While the Homes continue to transition to their new operating model, one-time funding of \$6 million is included for MVFA and \$4 million is provided for Grand Rapids to ensure the transition occurs smoothly and resident member needs are met.
- The budget also increases assumed Medicaid (CMS federal) revenue, with a corresponding ongoing GF offset.
