



I am notably concerned about the proposed 20% cut to funding that would impact the school that I attend, Uplift Michigan Online School. As a student who has chosen to attend an online school, I can tell you that these schools are important for students like me because UMOS provides me and many other students with a safe place to learn, and the tools and flexibility to do it.

I chose to attend a cyber/online school because brick-and-mortar schools couldn't keep us safe. I joined UMOS back in the pandemic, back when just about everyone was convinced that COVID wasn't even real. My in-person school at the time believed the same, and it was only until the virus had made full landfall in the country and had started to take lives that they reluctantly moved everyone to an impromptu online schooling curriculum. Following that, I left the program and joined UMOS, because they weren't mentally unstable enough to encourage students to come back to in-person schooling in the middle of a blasted pandemic. Now that the pandemic has mostly moved on, those schools are still dangerous, especially to those who don't inherently fall into a high-ranking social clique of idiots. The frequency of excessive bullying and violence between students has only increased since I last went to a physical school, and now more than ever those bullies and inciters-of-violence have targets: people who don't fall into a specific category of "straight and white". People who are part of LGBTQ+ communities, members of ethnic or racial minority groups, those with mental disorders or other conditions, and even people who just don't fit in very well are all at a higher risk than ever of violence towards them and those they care about. And considering that the 20% of the budget you're trying to take from online schools probably isn't going to be used to combat issues like that effectively, you really don't have a viable reason to cut it from us.

Additionally, the amount of school shootings has also increased tenfold. Just in the past three months, there have been at least two or three major shootings that made national news, and claimed the lives of many innocent people. People that YOU are supposed to keep safe and healthy. And from my logical deduction, taking money from programs that can give students and parents alike a breath of relief, knowing that the chance of their child living to see another day has increased substantially, isn't going to mitigate those incidents.

UMOS has given me, my family, and so many others reassurance and confidence that their children will be safe and healthy while they're schooling. That they don't have to give their kid body armour to get a good education; that their child will be able to go back to school the next day, alive and well.

Online programs like UMOS have also helped many people come to terms with things like gender and sexual identity without facing excessive judgement or violence. People who have

questioned whether they fall into a different category or title than what they were born into are able to breathe freely and experiment a little more, because they won't be slammed against a wall or shoved into a locker for doing so.

Moving aside from worries of violence and fear of judgement/discrimination, online schools are also far more flexible than a standard, physical location. While you are required (and expected) to complete the assigned work efficiently and effectively, you are given far more leeway in how it should be done, and when it should be done. If you prefer to get one or two subjects out of the way before the others, UMOS gives you the ability to do exactly that. You can work on one subject per day, allowing for higher grades and better retention of applicable information. If you are forced to switch between all of your subjects in one day, it can limit the amount of information you actually remember, making most of the time spent in the class absolutely useless. It also allows students with an erratic schedule to complete the assigned work as they are able to, and not have to worry about receiving a lower grade for being a day late in submission. Many students have parents or guardians who lead busy lives, or are constantly on the move (such as stationed military personnel, or government operatives/officials), and as such can struggle to adhere to a standard in-person schooling schedule, especially in regards to completing assigned work. UMOS and other programs of it's nature can help to mitigate this problem, and help the student complete all the necessary assignments to the best of their ability.

Online programs also allow for students to have more individualised interactions with teachers and administrators. If a student is struggling in a specific subject, or is facing other problems, they can convey their concerns and receive help from teachers and other staff members notably easier, and with far less social anxiety, due to smaller class sizes and the integration of technology. In a standard, physical schooling environment, many students will fall behind in classes, or continue to face other problems, because of social anxiety caused by large class sizes, and the need to engage in direct, face-to-face interactions with teachers and staff.

The proposed 20% funding cut to cyber school funding would have a huge impact on my education and the education of thousands of students like me. By cutting funds to UMOS and similar programs, many of those students will be denied access to needed technology and resources that are provided by the program, such as personal computers, stationary, books and documents, et cetera. They will also have to deal with larger class sizes, lack of qualified teachers and staff, a less coherent curriculum and assignments, and a generally lower quality of education. As one can assume, changes of this nature can be catastrophic to some and frustrating/inconvenient to others, which will in turn produce less successful students (which can also lead to a lower employment rate from the lack of qualified graduates, meaning the

economy also takes a major hit). Overall, it is extremely nonoptimal and inconvenient to cut funding from UMOS and similar online schooling programs.

I urge you to reconsider this proposed funding cut so that students like us can continue to receive the education that we need to succeed. Thank you for your time and consideration.

Dear Michigan Lawmakers,

I'm writing to you because the Governor's proposed budget has a 20% reduction in per pupil funding to cyber charter schools. I'm the superintendent at Uplift Michigan Online School, a cyber charter school. I have first hand knowledge of the types of expenses and experiences cyber charter schools have. This cut is unacceptable and discriminatory. It should NOT be allowed to happen. It shouldn't even be a discussion point. Not only does cutting funding for students (in any school, anywhere, for any reason) make NO sense at this time but it sends a terrible message to children and parents about the worth of their children. Equally, it sends a terrible message to charter educators that they're not REAL educators; that the schools they serve are "less than." How can we do that ever, let alone in today's climate?

There's no place for funding cuts to schools!

We're in an unprecedented time of major learning loss, mental health challenges, and teacher shortages. The idea that we would cut funding, for any reason, to a school is insane to me. Especially cutting funding to schools that really stepped up during the pandemic to provide scared children with safety, support, and a consistent education.

Cyber charter schools don't have all of the same expenses as traditional schools. That's 100% true. Just because they don't have the same expenses doesn't mean they aren't spending the same on kids!!!! Traditional schools receive and leverage millages and bonds to bolster their funding (and pay for buildings). Charter schools and cyber charters can't do that. Which already puts them at a funding deficit, per pupil. Cyber charters also don't have transportation and food service needs that mirror traditional schools. However, cyber charters DO have the technology, curriculum, and unique staffing costs that require just as much funding. Ex: a traditional school doesn't have to pay for dozens of sites, travel costs, and preparation costs for state testing administration that cyber charters do.

The funding needs for cyber charters aren't less. They're just different. Cutting this funding would cripple schools like the one I work at and my children attend. Those cuts would mean cuts to staffing, support, programming, and resources. ALL of the things we know kids need right now, we would be forcing schools to cut. Forcing schools to make a choice between rising to meet the mental health needs of our children and providing a certified educator for their classroom. That's a no-win decision. It hurts everyone and helps NO ONE.

I want to really encourage you to talk amongst your members and have them reach out to cyber charter schools. Attend classes, and see what we do. Before you consider cutting funding for our children you should take the time to see what is actually happening in these schools and give us a chance to show you why you can't cut our funding.

Now is not the time to send the message that some kids are more valuable than others!

Now is not the time to start a conversation about whether or not our lawmakers in Michigan are discriminating against children, because that's what this is. It's discrimination at the highest degree. It's wrong.

Before you consider this cut and vote for it, you should meet with staff, parents, and children served by these schools. You should be forced to tell our educators that they aren't worth the same as unionized educators. That our children aren't worth the same as the kid showing up to a building every day and sleeping at their desk.

Fund ALL kids. Hard stop. No discrimination. No playing politics with children or their education.

There has got to be a better use of your time and efforts than cutting funding to any school in a climate in which being an educator is undervalued, underappreciated, and underpaid. I'm truly disappointed in our Governor for suggesting that some children are worth more than others. It's deplorable and none of you should support it. I feel that your mission has been to placate unions and not help people. The unions don't run our government. They shouldn't get to tell you what talking points you can have. The teachers union hates charter schools and charter school educators. They make that well known. What does that do? How does that benefit kids?

What it does... it pits highly-qualified, certified, well-educated and well-in-debt educators against one another rather than having them fighting for what's best for kids. How does that benefit kids... it doesn't! We can do better! I hope you can see that and partner with me/us to do that.







I have helped teen parents get their diploma with a toddler to care for, where if they didn't have a virtual option, they would have dropped out entirely. I have seen our valedictorian sore to new height when his options for education and courses were expanded to more than what was offered at his local brick-and-mortar, including AP options which were never available to him in the past. I have seen families experience homelessness and housing/food instability, and while they were able to move around to wherever they could find a warm place to sleep, their student still had a consistent and challenging educational throughout the whole experience.


While I know it seems like a cut like this to cyber schools shouldn't impact their ability to educate because it is assumed that cyber schools have fewer expenses, this is simply not the case. Cyber schools are not entitled to local milages and bonds, as well as not entitled to local taxes to support our work. This is already a significant difference in our income in comparison to brick-and-mortar schools. This cut would greatly impact not just our school, but most of all the support and education we can provide to our STUDENTS. This cut will directly impact the STUDENTS in your neighborhoods.




