### What We Do

#### DATA

Collect and share research and stories about the impact of OST on kids and families

Track data on the demand for programs in Michigan and trends showing what families need

#### QUALITY

Professional development and training opportunities for providers

Administer the MI-YDA credential in partnership with the Michigan Department of Education

Promote the Michigan Out-of-School Time (MOST) quality standards

#### ADVOCACY

Support public and private funding for OST programs

Inform policies that build a stronger and more equitable system


Equip youth, parents, program leaders & partners to advocate for OST in their communities

81% are building confidence



**82%** are learning responsible decision-making




82% are getting homework help



**78%** are engaging in STEM learning opportunities



**82%** are taking part in physical activities



#### **OST** in Michigan: Unmet Demand

**750,000** kids in Michigan would enroll in an afterschool program if one were available to them

There are **376 kids for every program** in Michigan


Parents say the biggest barriers are:

- Program availability
- Cost
- Transportation

For every child in afterschool in Michigan, **4 more are waiting** for an available program

# State Funding for OST: 32n Grant Program

- MASP works with MiLEAP & MDE to support grant competition, grantees and Michigan Out of School Time (MOST) Committee
- Who's eligible? Community-based organizations, higher education institutions, community and adult education programs, libraries, local governments, school districts
- Grantees must serve K-12<sup>th</sup> Graders & include programming to support math, science, reading & wellness











# 32n FY2023: What Parents Say




