COMMITTEE MEETING MINUTES

Wednesday, June 17, 9:00 Room 352, House Appropriations, State Capitol 2020 AM Building

The House Committee on Appropriations was called to order by Chair Hernandez.

Representative Whiteford moved to adopt the meeting minutes from June 3, 2020. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5761 and HB 5810 before the committee:

HB 5761 (Rep. Lower) A bill to amend 1893 PA 206, entitled "The

general property tax act," (MCL 211.1 to 211.155)

by adding sections 44e and 78t.

HB 5810 (Rep. Lower) A bill to amend 1893 PA 206, entitled "The

general property tax act," by amending section 78a (MCL 211.78a), as amended by 2014 PA 499, and

by adding section 44e.

2. Amend page 3, following line 26, by inserting:

"DEPARTMENT OF ATTORNEY GENERAL

Sec. 301. Funds appropriated in part 1 for Edenville dam investigation shall be used to support costs related to investigating events leading to the Edenville dam failure, determining the party, or parties, responsible for the failure, and supporting efforts to recoup expenses from damages caused by the dam failure from the party, or parties, responsible for the failure.

DEPARTMENT OF ENVIRONMENT, GREAT LAKES, AND ENERGY

Sec. 401. Funds appropriated in part 1 for land and water interface permit programs shall be used by the department of environment, Great Lakes, and energy to review dam inspection policies, support ongoing dam investigations, and provide recommendations to the legislature about needed dam inspection policies and funding within 90 days." and renumbering the remaining sections.

"DEPARTMENT OF ENVIRONMENT, GREAT LAKES, AND ENERGY

Sec. 301. Funds appropriated in part 1 for dam repairs, in addition to any unencumbered and unobligated funds the department has for dam repairs, shall be used by the department to pursue repairs to dams that are in most immediate need and dams deemed by the department to be highly hazardous. Funds may be used to pursue enforcement measures and to inform the public of potential high hazard dam failures at privately-owned dams." and renumbering the remaining sections.

"Sec. 302. By September 30, 2020, the department shall submit a report to the senate and house appropriations committees and the senate and house fiscal agencies that includes all of the following information:

- (a) The name and location of any entity that received funding from the disaster and emergency contingency fund for costs related to the Edenville and Sanford dam incidents.
 - (b) The purpose and use of each expenditure that was made.
- (c) The amount of federal funding that was provided for flood response related to the Edenville and Sanford dam incidents and an itemization of any expenses covered by the disaster and emergency contingency fund related to these incidents that are eligible for reimbursement.
- (d) The status of any programs that received support from the disaster and emergency contingency fund due to the Edenville and Sanford dam incidents.
- (e) The job titles and number of state full-time equated positions, broken down by department, that were engaged in responding to the Edenville and Sanford dam incidents.
- (f) A listing of all local and county units that applied for disaster and emergency contingency fund assistance grants and the determination that was made on each of these applications.".

Assistance grants may be made from the funding appropriated in part 1 to local units that declared a state of emergency related to excessive rainfall and resulting flooding that occurred during May 2020. These grants are subject to amount restrictions established in section 19 of the emergency management act, 1976 PA 390, being MCL 30.419.".

1. Amend page 3, following line 28, by striking out all of section 301 and inserting:

"Sec. 301. (1) Funds appropriated in part 1 from the disaster and emergency contingency fund shall be allocated to a county with a population of more than 80,000 and less than 85,000, to a county with a population of more than 200,000 and less than 205,000, to a county with a population of more than 15,000 and less than 16,000, to a county with a population of more than 25,600 and less than 25,700, to a county with a population of more than 25,800 and less than 25,900, and to a city with a population of more than 35,000 located in a county with a population of more than 80,000 and less than 85,000, according to the most recent federal decennial census. Funding shall be used to reimburse project restoration costs and expenses caused by the federally declared disaster impacting those counties. Restoration projects include, but are not limited to, debris removal, emergency protective measures such as road blockades, sheltering, and evacuations, chemical contamination clean-up efforts, and the repair of real estate and personal property.

(2) Funding appropriated in part 1 for grants to counties or municipalities must be made in accordance with section 19 of the emergency management act, 1976 PA 390, being MCL 30.419.".

1. Amend page 3, following line 28, by striking out all of section 301 and inserting:

"Sec. 301. (1) Funds appropriated in part 1 from the disaster and emergency contingency fund shall be allocated to a county with a population of more than 80,000 and less than 85,000 and to a city with a population of more than 35,000 located in a county with a population of more than 80,000 and less than 85,000, according to the most recent federal decennial census. Funding shall be used to reimburse project restoration costs and expenses caused by the federally declared disaster in that county. Restoration projects include, but are not limited to, debris removal, emergency protective measures such as road blockades, sheltering, and evacuations, chemical contamination clean-up efforts, and the repaid of real estate and personal property. Expenditures for chemical contamination clean-up efforts must not be made on projects where existing parties are responsible for monitoring and remediating contaminated properties.

(2) Funds must be allocated with priority given to supporting housing assistance costs for individuals displaced from their residence.".
