The House Standing Committee on Families, Children, and Seniors was called to order by the Chair Crawford.

Representative B Carter moved to adopt the meeting minutes from May 15, 2019. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4223 before the committee:

HB 4223 (Rep. VanSingel) A bill to amend 1978 PA 368,

entitled "Public health code," by amending the heading of part 93 and sections 9307 and 9321 (MCL 333.9307 and 333.9321), and by adding sections 9312 and 9316.

The Chair offered and explained the substitute (H-1) for House Bill 4223.

Representative Wozniak moved to adopt substitute (H-1) to HB 4223. The motion prevailed 7-0-0:
