The Chair laid HCR 0002 before the committee:

HCR 0002

(Rep. Vaupel) A concurrent resolution to declare Adverse Childhood Experiences (ACEs) a critical health issue, commit the Legislature to action, and encourage the Governor to direct agencies to assess and report progress on reducing ACEs.

Representative Hank Vaupel, the resolution sponsor, explained his resolution HCR2 to the committee, and introduced Rick Murdock, former Director of the Michigan Association of Health Plans (MAHP), and now Coordinator of the Michigan ACE Initiative for the MAHP Foundation, who testified in support of HCR 0002. Discussion and Questions followed. A copy of his written testimony and handouts are attached.

Lisa Farnum, Managing Director for the Michigan Association of Health Plans Foundation, submitted a card in support of HCR 2.

The following individuals submitted a card in support of HCR 0002, but did not wish to speak: Christine Shearer, Deputy Director in the Office of Legislation and Advocacy at Michigan Association of Health Plans;
