The House Standing Committee on Health Policy was called to order by the Chair.

Representative Frederick moved to adopt the meeting minutes from April 18, 2019. There being no objection, the motion prevailed by unanimous consent.

The Chair welcomed the physicians and students from the Michigan College of Emergency Physicians, and the Leadership Development Program.

The Chair laid HB 4056 before the committee:

HB 4056

(Rep. Anthony) A bill to amend 2014 PA 462, entitled "An act to allow peace officers to carry and administer opioid antagonists in certain circumstances; to provide access to opioid antagonists by law enforcement agencies and peace officers; and to limit the civil and criminal liability of law enforcement agencies and peace officers for the possession, distribution, and use of opioid antagonists under certain circumstances," by amending section 1 (MCL 28.541).
