COMMITTEE MEETING MINUTES

Tuesday, February 26, 2019

The House Standing Committee on Judiciary was called to order by Chairman Filler.

The Chair requested attendance be called:

Representative LaFave moved to adopt the meeting minutes from February 19, 2019. There being no objection, the motion prevailed by unanimous consent.

Representative LaGrand moved to excuse absent members from the meeting. Without objection Rep. Yancey was excused from the meeting.

The Chair laid HB 4161 and SB 87 before the committee:

SB 87 (Sen. McBroom) A bill to amend 1961 PA 236, entitled "Revised judicature act of

1961,"by amending section 8160 (MCL 600.8160), as amended by

2012 PA 21.

SB 2	(Sen. Lucido)	A bill to amend 1978 PA 368, entitled "Public health code," by amending section 7523 (MCL 333.7523), as amended by 2016 PA 418, and by adding section 7521a.
