# **COMMITTEE MEETING MINUTES**

The House Standing Committee on Judiciary was called to order by the Chair.

Representative LaFave moved to adopt the meeting minutes from April 30, 2019. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4407 before the committee:

HB 4407

(Rep. Guerra) A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"by amending section 8512 (MCL 600.8512), as amended by 2014 PA 384.

Representative Guerra; Tom Clement, representing the State Court Administrative Office; and Sheldon Larky, representing himself, testified together in support of the bill. Questions and discussion followed.

2016 PA 88.
