The House Standing Committee on Judiciary was called to order by Chair Filler.

(Rep. Filler) A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 539c (MCL 750.539c).

HB 4258	(Rep. Yancey) A bill to amend 1998 PA 386, entitled "Estates and protected individuals code," by amending section 2802 (MCL 700.2802), as amended by 2012 PA 173.
HB 4259	(Rep. Guerra) A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16i of chapter XVII (MCL 777.16i), as amended by 2012 PA 169.
HB 4260	(Rep. Anthony) A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 174a (MCL 750.174a), as amended by 2013 PA 34.
HB 4265	(Rep. Farrington) A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16g of chapter XVII (MCL 777.16g), as amended by 2017 PA 74.
