The House Standing Committee on Local Government and Municipal Finance was called to order by Chair Lower.

The Chair laid HB 4851 before the committee:

HB 4851(Rep. Hoitenga) A bill to amend 1893 PA 206, entitled "The
general property tax act," by amending sections 7b and 53b
(MCL 211.7b and 211.53b), section 7b as amended by 2013
PA 161 and section 53b as amended by 2017 PA 261.

Representative Marino moved to adopt substitute (H-1) to HB 4851. The motion prevailed 13-0-0:

The Chair laid HB 4915 before the committee:

HB 4915 (Rep. Berman) A bill to establish liability and provide remedies for damage resulting from falling trees or tree branches.

Representative Berman and Dr. Lance Stokes, representing himself as a West Bloomfield resident, testified in support of HB 4915. Questions and discussion followed.

Brian Westin, representing Michigan Realtors Association, testified with no position on HB 4915. Questions and discussion followed.
