The House Standing Committee on Transportation was called to order by Chair O'Malley.

The Chair requested attendance be called:

Representative Bellino moved to adopt the meeting minutes from October 29, 2019. There being no objection, the motion prevailed by unanimous consent.

The Chair laid SB 527 before the committee:

SB 527

(Sen. Victory) A bill to amend 2001 PA 142, entitled "Michigan memorial highway act," by amending section 11 (MCL 250.1011) and by adding section 11c.

Amber Vrooman, representing Senator Victory's office, testified in support of SB 527.

Representative Alexander explained her proposed substitute (H-3) to HB 5100. Questions and discussion followed.

Representative Eisen moved to adopt substitute (H-3) to HB 5100. The motion prevailed 8-4-1:

SB 309 (Sen. Zorn) A bill to amend 1933 PA 254, entitled "The motor carrier act," by amending sections 2 and 8 of article IV (MCL 478.2 and 478.8), section 2 of article IV as amended

by 2014 PA 493 and section 8 of article IV as added by 1988 PA 369.

Representative Cole moved to refer Senate Bill No. 309 to the committee on Ways and Means.

HB 4924 (Rep. Anthony) A bill to amend 1931 PA 328, entitled "The Michigan penal code," (MCL 750.1 to 750.568) by adding section 421d.

Representative Anthony and Representative Lilly testified in support of HB 4923 and HB 4924.

Joe Sproles, representing the Alliance of Automobile Manufactures, joined by Craig Orlan, representing Honda North America, both testified in support of HB 4923 and HB 4924.
