Dear Representative Filler, Representative Mueller, and Representative LaGrand:

The purpose of this email is to encourage the Judiciary Committee to grant a hearing for HB 4159 and HB 4160. Attached please find a formal Letter of Support for the bills, complete with tables that summarize extensive disability policy research.

My colleague, Dr. Marsack-Topolewski, and I have analyzed a wealth of information on why these bills must become state law. The bills focus on an offender's actions to exploit a Vulnerable Adult into sharing sexually explicit visual material of the Vulnerable Adult. These are situations of online exploitation where there is no mutual consent. Current statutes do not hold online exploiters accountable and deter would-be predators. As the attached letter states, it is well documented that Vulnerable Adults:

1. Are specifically targeted by online predators;
2. Face *the* highest risk of online abuse/exploitation; and
3. Suffer severe and often permanent emotional damages as a result of online abuse.

We appreciate your time to review and consider this attachment. Of course, please do not hesitate to reach out if we can provide you with any additional information in advance of a hearing.

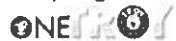

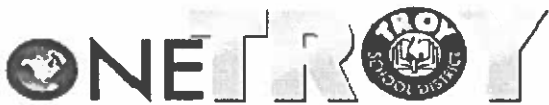

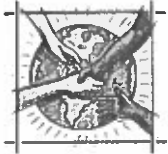
