# **COMMITTEE MEETING MINUTES**

Wednesday, February 24, 2021 12:00 PM Room 352, House Appropriations, State Capitol Building

The House Committee on Health Policy was called to order by the Chair Kahle.

HB 4043	(Rep. Whiteford)	A bill to amend 1974 PA 258, entitled "Mental health code," by amending section 151 (MCL 330.1151), as added by 2018 PA 658.
HB 4044	(Rep. Whiteford)	A bill to amend 1974 PA 258, entitled "Mental health code," by amending section 165 (MCL 330.1165), as added by 2020 PA 12.
HB 4067	(Rep. Frederick)	A bill to amend 1978 PA 368, entitled "Public health code," by amending sections 16605 and 16608 (MCL 333.16605 and 333.16608), section 16605 as amended by 2018 PA 463 and section 16608 as amended by 2002 PA 643.
