The Chair laid HB 4345 before the committee:

HB 4345 (Rep. Beeler) A bill to amend 1956 PA 218, entitled "The

insurance code of 1956," (MCL 500.100 to

500.8302) by adding section 3406v.

Representative Beeler, testified in support of HB 4345. Questions and discussion followed.

Karen Jonas, representing the Michigan Association of Health Plans, testified in opposition to HB 4345. Questions and discussion followed.

The Chair laid HB 4347 before the committee:

HB 4347 (Rep. Witwer) A bill to require drug manufacturers to report

certain information to the department of insurance and financial services; to provide for the powers and duties of certain state officers and entities; to allow for the promulgation of rules; and to prescribe civil sanctions.
