## **COMMITTEE MEETING MINUTES**

The House Committee on Insurance was called to order by Chair Rendon.

SB 447 (Sen. Lauwers)

A bill to amend 1956 PA 218, entitled "The insurance code of 1956," (MCL 500.100 to

500.8302) by adding section 3471.
