HB 4150	(Rep. Glenn)	A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 802 (MCL 257.802), as amended by 2019 PA 88.
HB 4151	(Rep. Steven Johnson)	A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 43560 (MCL 324.43560), as added by 1995 PA 57.
HB 4152	(Rep. Howell)	A bill to amend 1994 PA 451, entitled "Natural
