### **COMMITTEE MEETING MINUTES**

The House Committee on Judiciary was called to order by Chair Filler.

The Chair laid HB 4138 before the committee:

HB 4138 (Rep. Alexander)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 82113 (MCL 324.82113), as

#### amended by 1998 PA 297.

DJ Hilson, Muskegon County Prosecutor, representing the Prosecuting Attorneys Association of Michigan, testified in support of HB 4627. Questions and discussion followed.

Dan Pfannes, representing the Michigan Sheriff's Association and the Michigan Association of Chiefs of Police, testified in support of HB 4627. Questions and discussion followed.
