COMMITTEE MEETING MINUTES

Tuesday, May 11, 2021

The House Committee on Judiciary was called to order by Chairman Filler.

The Chair requested attendance be called:

Representative Mueller moved to adopt the meeting minutes from May 4, 2021. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4698 before the committee:

HB 4698 (Rep. Albert)	A bill to amend 1931 PA 328, entitled "The

HB 4632	(Rep. Garza)	A bill to amend 1978 PA 368, entitled "Public health code," by amending section 7523a (MCL 333.7523a), as added by 2019 PA 8.

"(7) If property is seized in Wayne County by law enforcement officers appointed by a public airport authority created under section 110 of the aeronautics code of the state of Michigan, 1945 PA 327, MCL 259.110, or by a regional airport authority created under section 139 of the aeronautics code of the state of Michigan, 1945 PA 327, MCL 259.139, and is subsequently forfeited in Wayne County, any forfeited money must be directed to the conviction integrity unit within the Wayne County prosecutor's office.".

Representative Steven Johnson moved to adopt the amendment to HB 4632. The motion did not prevail 4-6-1:

HB 4092	(Rep. Filler)	A bill to amend 1927 PA 175, entitled "The code of criminal procedure," (MCL 760.1 to 777.69) by adding section 21d to chapter VIII.
HB 4093	(Rep. Kahle)	A bill to amend 1939 PA 288, entitled "Probate code of 1939," by amending section 18e of chapter XIIA (MCL 712A.18e), as amended by 2020 PA 361.
HB 4214	(Rep. Mueller)	A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 27c of chapter VIII (MCL 768.27c), as added by 2006 PA 79.
