## **COMMITTEE MEETING MINUTES**

The House Committee on Judiciary was called to order by Chair Filler.

Chairman Filler laid before the committee a presentation by the State Court Administrative Office, on proposed rule change regarding virtual hearings.

Tom Boyd, representing the State Court Administrative Office, gave a presentation to the committee. Questions and discussion followed.

HJRQ (Rep. Allor)

A joint resolution proposing an amendment to the state constitution of 1963, by amending section 19 of article VI, to increase the age limitation criterion for judicial office.

Judge Peter O'Connell testified in support of HJRQ. Questions and discussion followed.

HB 5749 (Rep. Fink)

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 8202 (MCL 600.8202), as amended by 2016 PA 31.
