The House Committee on Local Government and Municipal Finance was called to order by Chair Calley.

Representatives Howell, Berman, Garza and Kuppa joined the committee remotely.

The Chair laid SB 362, SB 364, SB 422 and SB 432 before the committee:

SB 362 (Sen. Brinks)

A bill to provide for the establishment of attainable housing districts in certain local governmental units; to provide for the exemption from certain taxes; to levy and collect a specific tax upon the owners of certain qualified facilities; to provide for the disposition of the tax; to provide for the obtaining and transferring of an exemption certificate and to prescribe the contents of those certain state and local governmental officials; and to provide penalties.

SB 364 (Sen. Moss)

A bill to amend 1992 PA 147, entitled "Neighborhood enterprise zone act," by amending sections 2 and 3 (MCL 207.772 and 207.773), section 2 as amended by 2020 PA 3 and section 3 as amended by 2008 PA 204.

SB 422 (Sen. Horn)

A bill to provide for the establishment of residential housing districts in certain local governmental units; to provide for the exemption from certain taxes; to levy and collect a specific tax upon the owners of certain qualified residential facilities; to provide for the disposition of the tax; to provide for the obtaining and transferring of an exemption certificate and to prescribe the contents of those certificates; to prescribe the powers and duties of certain state and local governmental officials; and to provide penalties.

SB 432 (Sen. Schmidt)

A bill to amend 1966 PA 346, entitled "State housing development authority act of 1966," by amending section 15a (MCL 125.1415a), as amended by 1994 PA 363.

Joshua Lunger, representing the Grand Rapids Chamber, Senator Brinks, Senator Schmidt, and Senator Moss testified in support of SB 362, SB 364, SB 422 and SB 432. Questions and discussion followed.
