HB 5359 (Rep. Cherry)	A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding sections 48714a and 48714b.
HB 5360 (Rep. Martin)	A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by

amended by 2016 PA 382.
