Hello, My name is Kerry Lynn Elieff. I intended to come to the hearing and vote regarding HB4677 however, I have a zoom medical meeting that I need to be in. However, I want to share some issues/facts that I have concerning the vaccination passports in urging for a vote to support the banning of vaccine passports.

In recent weeks, we have seen Governor Whitmer come out with her steps on reopening Michigan all based around coercion to get the vaccine.

55% of Michigan people vaccinated, in person work can resume..... All the way up to 70% no more need for masks. All of this is concerning and looks to be leaning in the way of mandating that if you are not vaccinated, then you can not do thus and so, work, buy, play sports, attend concerts....

Governor Whitmer is stating this based on an EXPERIMENTAL vaccine that has gotten authorization from the FDA for emergency use but is not FDA approved.

We have seen Governor Whitmer time and again make flippant decisions not based on Science. The Supreme Court ruled that Governor Whitmer's Executive Orders based on the 1945 law were UNCONSTITUTIONAL after April 30, 2020. Immediately after that she got the Health Department MDHHS Chief Gordon and Joneigh Khaldun to do her work for her in keeping her orders alive and well. It has been like trying to nail jell-o to the wall. All of these current orders are unlawful.

This committee held a hearing a few weeks ago with former Chief Gordon regarding the questions to his receiving an inordinate amount of taxpayer money to keep from bringing suit only for him to say, he had no reason to bring suit. (I sincerely hope you do not let this issue drop but fully investigate and get that money back to the taxpayers and when finding any laws broken, there will be indictments.

There are several problems with the above mandates of coercing people to get the vaccine and revealing how imperative it is to pass HB4667 immediately to ban any attempt to make vaccine passports a law.

1. It goes against our liberties based on the U.S. as well as the Michigan Constitution Sec. 1 and Sec. 9 involuntary servitude.
2. There are some people who cannot take vaccines because of allergies to vaccines. I had an allergy to the Tetnus vaccine and I have not been able to have one since nor have I been able to take any other vaccine. My youngest daughter who turned 18 today, as an infant, got her immunization shots and that night spiked a high temp and went into a drone state after that. She just stared blank with no expression. I am writing to urge you to do everything you can do to enact a permanent prohibition on the use of any type of health passport by government or private entities. Very simply, they are coercive and un-American.

White House press secretary Jen Psaki recently remarked that vaccine passport efforts will be driven by the private sector. Whether the programs are implemented by the government or a private business, know that any type of health passport threatens our freedom and fundamental rights.

Many laws are being introduced to protect against inquiring into a person's vaccination status and to protect individual "right of access" to public accommodations so people can work, freely move about society and receive basic benefits like food assistance - irrespective of their medical decisions. Please actively support these bills to make vaccine passports illegal. Explicit protections are necessary or we will quickly become a society where it's acceptable to be asked to "show your papers."

Imagine being denied access to the community where you live or not being able to frequent the businesses there because you don't have proper documentation (or don't want to show that documentation). This is precisely what lies ahead for the American public if you allow vaccine passports to be ushered in.

Although vaccine passports are being touted as vital tools that will restore normalcy and allow our country to reopen safely, experts say that the cost of their use is too high. They threaten our basic human rights, our civil rights and our democracy by creating policies that combine elements of Jim Crow, Apartheid and Nazism. At present, nearly 20 vaccine passports are under development in the United States. If they are widely instituted, they will quickly create a two-tiered, caste-like society of haves and have-nots and desirables and undesirables. Segregation, which this country fought for so long to abolish, will once again be rampant.

Passports also raise serious privacy concerns and present a clear opportunity for major data breaches and misuse of individuals' most personal information. According to the ACLU, which has taken a strong stand against vaccine passports, it's altogether different for an employee to voluntarily disclose his or her COVID-19 status to an employer on a one-off basis than it is to collect and retain information. The ACLU has also warned that vaccine passports stand to disproportionately harm the most vulnerable members of society. For example, for single mothers, pregnant women, minorities and those who are economically disadvantaged, failure to comply could mean starvation, homelessness or the inability to receive needed medical care.

It's unacceptable to restrict the rights of individuals based on their personal health decisions or vaccine status. The Universal Declaration of Human Rights was enacted in 1948 to protect against such abuses. It states, "Everyone has the right to freely participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits."

Americans have been through enough over the past year, and many are living under extremely dire circumstances. Please do your part to protect us from further harm by ensuring that the extraordinarily powerful pharmaceutical industry, the regulatory agencies that govern pharma, and the public-private partnerships that stand to make billions off of passports do not have the final say in shaping our culture and how we live our day-to-day lives. Our basic human rights and our democracy depend on it.
