COMMITTEE MEETING MINUTES

Tuesday, May 18, 10:30 Room 352, House Appropriations, State Capitol 2021 AM Building

The House Committee on Regulatory Reform was called to order by Chair Hauck.

Representative Bellino moved to adopt the meeting minutes from May 11, 2021. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4780, HB 4781, HB 4782 and HB 4783 before the committee:

HB 4780 (Rep. Mueller) A bill to amend 1976 IL 1, entitled "A petition to

initiate legislation to provide for the use of returnable containers for soft drinks, soda water,

carbonated natural or mineral water, other

nonalcoholic carbonated drink, and for beer, ale, or other malt drink of whatever alcoholic content, and for certain other beverage containers; to provide for the use of unredeemed bottle deposits; to prescribe the powers and duties of certain state agencies and officials; and to prescribe penalties and provide remedies," (MCL 445.571 to 445.576) by adding section 4c.

HB 4782 (Rep. Sneller)

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 14h of chapter XVII (MCL 777.14h), as amended by 2019 PA 49.

HB 4783 (Rep. Tyrone Carter)

A bill to amend 1976 IL 1, entitled "A petition to initiate legislation to provide for the use of returnable containers for soft drinks, soda water, carbonated natural or mineral water, other nonalcoholic carbonated drink, and for beer, ale, or other malt drink of whatever alcoholic content, and for certain other beverage containers; to provide for the use of unredeemed bottle deposits; to prescribe the powers and duties of certain state agencies and officials; and to prescribe penalties and provide remedies," by amending section 4 (MCL 445.574), as amended by 1998 PA 473.
