The House Committee on Regulatory Reform was called to order by Chair Hauck.

The Chair laid HB 5062 before the committee:

HB 5062 (Rep. Bolden)

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending section 521a (MCL 436.1521a), as amended by 2014 PA 270.

Representative Damoose moved to report out HB 5062 with recommendation. The motion prevailed 15-0-0:
