# **COMMITTEE MEETING MINUTES**

Tuesday, November 2, 2021 10:30 AM Room 519, House Office Building

The House Committee on Regulatory Reform was called to order by Chair Hauck.

The Chair requested attendance be called:

Representative Bellino moved to adopt the meeting minutes from October 26, 2021. There being no objection, the motion prevailed by unanimous consent.

The Chair laid before the committee a presentation by Kristan Sayers, President, and Mike Sarafa, Board Director, of the Michigan Association of Beauty Professionals. Questions and discussion followed.

The Chair laid HB 5055 before the committee:

HB 5055 (Rep. Posthumus)

A bill to amend 2016 PA 407, entitled "Skilled trades regulation act," by amending section 223 (MCL 339.5223), as added by 2021 PA 24, and by adding section 224.
