COMMITTEE MEETING MINUTES

Tuesday, April 26, 2022 10:30 AM Room 519, House Office Building

The House Committee on Regulatory Reform was called to order by Chair Hauck.

The Chair requested attendance be called:

Representatives Yancey and Garza joined the committee remotely.

Representative Bellino moved to adopt the meeting minutes from March 22, 2022. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5623 before the committee:

HB 5623 (Rep. Damoose) A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending section 513 (MCL 436.1513), as amended by 2020 PA 121.

Representative Damoose and Steve Betz, representing Lake Superior State University, testified in support of HB 5623.

The Chair laid HB 5983 and HB 5984 before the committee:

12526 (MCL 333.12521 and 333.12526), section 12521 as amended by 2004 PA 408, and by adding section 12526a.

HB 5984 (Rep. Cherry)A bill to amend 1998 PA 58, entitled "Michigan
liquor control code of 1998," (MCL 436.1101 to
436.2303) by adding section 548.
