The House Committee on Transportation was called to order by Chair O'Malley.

The Chair laid HB 4026 and HB 4117 before the committee:

HB 4026 (Rep. Eisen) A bill to amend 1949 PA 300, entitled "Michigan

vehicle code," by amending section 805 (MCL

257.805), as amended by 2013 PA 82.

HB 4117 (Rep. Steven Johnson) A bill to amend 1949 PA 300, entitled "Michigan

vehicle code," by amending section 226 (MCL

257.226), as amended by 2020 PA 304.
