vehicle code," by amending sections 221 and 310 (MCL 257.221 and 257.310), as amended by 2020

PA 93.

HB 4365 (Rep. Sneller) A bill to amend 1972 PA 222, entitled "An act to

provide for an official personal identification card; to provide for its form, issuance and use; to

regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations;

and to provide an appropriation for certain

purposes," by amending section 1 (MCL 28.291),

as amended by 2020 PA 92.

HB 4366 (Rep. Lilly) A bill to amend 2008 PA 23, entitled "Enhanced

driver license and enhanced official state personal

identification card act," by amending section 5 (MCL 28.305), as amended by 2020 PA 94.
