The House Committee on Transportation was called to order by Chair O'Malley.

The Chair laid HB 5370 before the committee:

HB 5370 (Rep. VanSingel)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 649a.

vehicle code," by amending sections 710d and 710e (MCL 257.710d and 257.710e), section 710d as amended by 2009 PA 57 and section 710e as

amended by 2016 PA 460.

HB 4984 (Rep. Clemente) A bill to amend 1949 PA 300, entitled "Michigan

vehicle code," by amending section 907 (MCL

257.907), as amended by 2020 PA 382.

Mark Griffin, representing the Michigan Petroleum Association, testified in support of SB 674. Questions and discussion followed.

Paul G. Connors, representing the Michigan Department of Treasury, testified with a neutral position on SB 674.
