The House Committee on Transportation was called to order by Chair O'Malley.

A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 552c (MCL 750.552c), as added by 2005 PA 305.

HB 5663 (Rep. Sneller)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending sections 306a, 312e, and 312f (MCL 257.306a, 257.312e, and 257.312f), sections 306a and 312f as amended by 2021 PA 71 and section 312e as amended by 2015 PA 11.

A bill to amend 1951 PA 51, entitled "An act to provide for the classification of all public roads, streets, and highways in this state, and for the revision of that classification and for additions to and deletions from each classification; to set up and establish the Michigan transportation fund; to provide for the deposits in the Michigan transportation fund of specific taxes on motor vehicles and motor vehicle fuels; to provide for the allocation of funds from the Michigan transportation fund and the use and administration of the fund for transportation purposes; to promote safe and efficient travel for motor vehicle drivers. bicyclists, pedestrians, and other legal users of roads, streets, and highways; to set up and establish the truck safety fund; to provide for the allocation of funds from the truck safety fund and administration of the fund for truck safety purposes; to set up and establish the Michigan truck safety commission; to establish certain standards for road contracts for certain businesses; to provide for the continuing review of

SB 466 (Sen. MacDonald)

resources and environmental protection act," by amending section 2045 (MCL 324.2045), as

amended by 2013 PA 81.

HB 5410 (Rep. Roth) A bill to amend 1994 PA 451, entitled "Natural

resources and environmental protection act," by amending section 2001 (MCL 324,2001), as

amended by 2010 PA 32.
