The Chair laid HB 5334 before the committee:

HB 5334 (Rep. Hauck)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 811hh.

Representative Roth moved to report out HB 5334 with recommendation. The motion prevailed 9-1-1:
