The House Committee on Transportation was called to order by Chair O'Malley.

Representatives Howell and Shannon joined the committee remotely.

Representative Roth moved to adopt the meeting minutes from June 30, 2022. There being no objection, the motion prevailed by unanimous consent.

Representative Puri moved to adopt the meeting minutes from September 13, 2022. There being no objection, the motion prevailed by unanimous consent.

The following person submitted a card with a neutral position on HB 6123, but did not wish to speak:

Representative Roth moved to report out HB 6123 with recommendation. The motion prevailed 9-2-0:

SB 640 (Sen. Zorn)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 722 (MCL 257.722), as amended by 2018 PA 274.

Representative Harris moved to report out SB 640 with recommendation. The motion prevailed 11-0-0:

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 606b (MCL 257.606b), as added by 2016 PA 332.

Representative Clemente offered the following amendment to HB 6369:

1. Amend page 2, following line 3, by inserting:

"Enacting section 1. This amendatory act does not take effect unless House Bill No. 5289 of the 101st Legislature is enacted into law.".

Representative Clemente moved to adopt the amendment. The motion did not prevail by a vote of 3-8-0.

Representative Clemente offered the following amendment to HB 6369:

Amend page 2, following line 3, by inserting:

"Enacting section 1. This amendatory act does not take effect unless House Bill No. 6364 of the 101st Legislature is enacted into law.".

Representative Clemente moved to adopt the amendment. The motion did not prevail by a vote of 3-7-1.
