COMMITTEE MEETING MINUTES

The House Committee on Workforce, Trades, and Talent was called to order by the Chair.

The Chair requested attendance be called. The Clerk called the attendance and a quorum was present.

Representative Howell moved to adopt the meeting minutes from June 17, 2021. There being no objections, the motion prevailed by unanimous consent.

The Chair laid SB 501 before the committee:

SB 501 (Sen. Horn)

A bill to amend 1936 (Ex Sess) PA 1, entitled "Michigan employment security act," by amending section 28 (MCL 421.28), as amended by 2020 PA 229.

Senator Ken Horn, the bill sponsor, explained SB 501, and introduced Jennifer Llewellyn, Director of Oakland County Michigan Works and Manager of Oakland County Workforce Development, and David Q. Worthams, Director of Human Resource Policy for the Michigan Manufacturers Association, who testified in support of SB 501. Questions followed. Written testimony is attached.

Stephanie Glidden, Chief of Staff and Legislative Liaison for Michigan's Unemployment Insurance Agency submitted a card with a neutral position on SB 501, but did not wish to speak.
