I have been working for almost 2 years to share the horrific nature of what goes on behind closed doors in regard to retail pet sales. So many of us worked tirelessly for over a year to get an ordinance in place to protect our community. We can't do this alone! We need state level support!

We support the bill fully but have particular expertise in rabbits, so the comments below focus on those issues.

Retail Pet Sale Bans Protect Rabbits from Cruel Mills

Virtually all rabbits supplied to pet stores are sourced from mills where animals are bred with little regard for their welfare. Animals are kept in stressful, crowded, unsanitary conditions, and ill and injured animals receive little to no veterinary care. According to the American Veterinary Medical Association's survey of households with companion animals, the top two sources for rabbits are gifts from friends or family (29%) and pet stores (27%). Considering many people who give rabbits as gifts initially purchase them at pet stores, banning retail sales would take a significant step toward shutting these mills down.

Few Federal or State Protections for Rabbits

While the federal Animal Welfare Act does regulate rabbit mills, it provides minimal protections and is chronically underenforced. Mills regulated by the Animal Welfare Act have long track records of poor animal care. Even facilities with prolific histories of neglect and abuse are rarely shut down. Instead, the US Department of Agriculture may issue warnings, negligible fines, or take no action at all.

Holmes Farm in Pennsylvania is one example of a rabbit mill. Holmes Farm housed more than 15,000 animals and supplied rabbits and other small mammals to pet stores, including Petco and PetSmart. At Holmes Farm, animals were killed with carbon dioxide or left to die in freezers even as some tried to escape. US Department of Agriculture inspection reports documented numerous Animal Welfare Act violations, including decomposing animals, filthy cages, cannibalization, and animals in desperate need of veterinary care.

In just a single USDA inspection report, the inspector noted ill animals with lethargy, hair loss, scabbing, skin conditions, diarrhea, and eye abnormalities, freshly and partially cannibalized hamsters, animals exhibiting abnormal stereotypic behavior, dead animals kept in cages with live animals, and filthy conditions, including water bottles with algae growing inside them.

Retail Rabbit Sales Increase the Burden on Shelters

After dogs and cats, rabbits are the third most surrendered animal to shelters. Stores selling rabbits significantly increase the burden on rescues and shelters that must pay for the cost of their care. It's unsurprising that rabbits are so frequently surrendered because, despite popular belief, they require complex care. Rabbits must be litterbox trained, and their environments must be "rabbit-proofed," or they will destroy electrical wires, walls, furniture, and plants. Extremely sensitive and easily frightened, rabbits are a challenging companion for children even though many parents purchase rabbits as gifts at Easter time. Despite this, pet stores entice customers to buy rabbits with little to no education or warning about the significant work it takes to care for a rabbit properly.

Some rabbits don't even make it to animal shelters. Rabbits are frequently abandoned outside in parks or streets to fend for themselves. Many rabbits die from starvation, are hit by cars, or are killed by other animals.

I believe this legislation is crucial for several reasons:

Addressing Lack of Oversight:

- Many retail pet businesses operate with minimal oversight, allowing inhumane practices to go unchecked.
- Retailers are not mandated to microchip, spay, or neuter animals, resulting in increased strays and overpopulation.
- These businesses often are not required to report when an animal dies, leading to neglect and mistreatment.
 - For example, Petland of Novi has been cited for allowing animals to die in their care due to lack of treatment for medical issues as recently as 2023 (source: Humane Society)

Improving Consumer Protection:

- Many pets sold in retail stores suffer from undetected congenital conditions or other health issues that result in high veterinary costs for unsuspecting buyers.
- Retail pet stores often use predatory lending practices allowing consumers to take home a
 dog for a small fraction of total price but with high double digit interest rates
- Adoption from shelters often includes spaying/neutering, vaccinations, and health checks, providing more transparency and assurance to pet owners.

Curbing Inhumane Breeding Practices:

Retail sales often source animals from puppy mills and large-scale breeding operations.

- These establishments frequently prioritize profit over animal welfare, leading to poor conditions and inadequate care.
- These environments typically lead to increased disease transmission, genetic disorders, and behavioral issues due to inadequate socialization.

Preventing Impulse Purchases:

- Reduces the likelihood of pets being abandoned or surrendered due to lack of preparation.
- Ensures that pet ownership is a well-considered, lifelong commitment

Decreasing Shelter Overcrowding:

- Pet stores contribute to overpopulation by supplying a constant influx of animals without addressing the existing surplus in shelters.
- Encouraging adoption helps manage the shelter population and reduces the number of animals euthanized due to lack of space.

Supporting Ethical Breeding Practices:

- A ban on retail sales will shift demand towards responsible breeders who prioritize the health and well-being of animals.
- Responsible breeders typically ensure animals are well-cared for and maintain higher standards of health and genetic quality.

Aligning with Proven Successes:

- California, New York, Colorado, Main, Maryland, Illinois, Washington and Oregon already have bans or heavy restrictions on sales of pets in retail establishments
- Said jurisdictions with similar bans have seen positive results, including lower rates of animal abandonment and better overall animal health.
- Data from these regions show a correlation between retail bans and decreased shelter intake rates.

I am part of a group which has been pushing for such a ban in Berkley, Michigan where a retail pet store opened in early 2023. The store owner has a documented history of sourcing from puppy mills and selling sick dogs among other unethical business practices. There have been challenges in passing such an ordinance in a municipality where a retail pet store already exists and the end result was an ordinance which bans future retail locations but allows the current one to continue operations. HB 4838 would ensure this cannot happen in any other municipalities.

I thank you for your time and encourage your support for this bill which can move Michigan into the future and away from outdated practices of animal neglect, abuse and cruelty.



I am writing to The House Committee on Government Operations about the Puppy Protection Bill, HB 4838 which is currently under consideration and which would prohibit the sale of dogs, cats, and rabbits in Michigan pet stores.

Public records show that Michigan pet stores sell puppies from puppy mills with awful animal welfare records, where there is little concern for the health and well-being of the animals. The same situations occur for cats and rabbits in pet stores. Families who purchase these animals from pet stores are often burdened with pet health problems that can cost thousands of dollars in veterinary bills or lead to a lifetime of medical complications. Importantly, the animals are also suffering, sometimes long-term.

During the Humane Society of the United States' most recent undercover investigation at a Petland store in Novi, Michigan, the hidden camera captured sick puppies, questionable veterinary care, and unsafe conditions. Several ailing puppies were sent back to their breeders, to unknown fates, instead of being given proper treatment. This investigation is just the latest of several conducted at Petland locations.

I strongly request that the House Committee on Government Operations prohibit selling dogs, cats, and rabbits in pet stores in Michigan. It is an inhumane practice. It also supports puppy mills that have little to no oversight from the local, state, or federal government. Michigan residents will still be able to get the pet of their choice from shelters, rescue centers, and responsible, licensed breeders.

I urge Chair Liberati, with the support of the Committee Members, to report HB 4838 out of committee. As a Michigan resident, I am urging you to end the sale of dogs from puppy mills and from unlicensed breeders in Michigan pet stores, and to end the sale of cats and rabbits in Michigan pet stores, by reporting HB 4838 out of committee.

I am writing to request that the committee vote in favor of House Bill 4838 and quickly advance it out of committee.

I understand that there are a large number of submissions regarding this bill, many of which contain important data regarding the devastating impact of puppy mills and their retail partners. I urge the committee to give special consideration to submissions from The Humane Society of the United States and Bailing out Benji. Both of these organizations have extensive, hands-on knowledge that make them ideally situated to advise on the issue of commercial animal breeding and retail sales.

I have been involved with animal welfare causes in Michigan for almost two decades as both an animal welfare professional and volunteer. I have seen bills similar to HB 4838 introduced in the Michigan legislature many times. Evey hearing has been well-attended, with massive amounts of largely favorable public input. Despite this overwhelming support, every bill has been ignored, narrowly defeated or scheduled for a hearing at the last possible moment in an attempt to avoid publicity or accountability.

I remember a protest I attended many years ago at the now shuttered Gibraltar Trade Center. At the time, it was a notorious venue for selling puppies linked to puppy mills. As we stood outside in a winter flurry, we were targeted by employees driving a snow plow which covered us with cold slush that froze in our hair and soaked through our gloves. This experience has stayed with me through the years because as we stood there, holding our signs in the brutal cold, we experienced a taste of what it is like for many mother dogs who are confined in Michigan puppy mills. They languish in minimal shelter, many of them in cages with wire-bottom floors. Exposed to the elements, these animals are deprived of everything that makes life worth living, bearing the physical burden of pregnancy, extreme temperatures and minimal socialization for the sole purpose of producing profitable offspring.

Nothing in our society can be produced at such a large scale without incurring significant labor costs. The hidden cost of pet store puppies is paid by their mothers, who will be forced to breed until they are no longer useful. Their fate is then left to an industry that has treated them as production machines, not beloved companions.

Our animal shelters and rescues bear the emotional, physical and financial burden caused by the puppy mill industry. From Midland to the <u>Upper Peninsula</u>, animal rescue organizations in Michigan have provided veterinary care, support, and rehoming services for animals seized from large scale, commercial breeders in our state. Enough is enough. Michiganders want to see this industry end. Our animal care organizations and the animals themselves deserve to be prioritized above the concerns of the few remaining pet stores that continue to sell puppies in a retail setting. We are a state of animal lovers; it's time that our government begins legislating in a way that reflects the deep affinity Michiganders have for their pets. Please support this bill and join Illinois, New York, California, Maryland and Maine in taking a stand against puppy mills.
