Dear Chair Liberati, Committee Members, and Representative Tsernoglou:

Thank you for the opportunity to testify. My name is Bee Friedlander, and I am the president of the Board of Directors of Michigan-based Attorneys for Animals, Inc., a non-profit and 501(c)(3) organization of legal professionals and animal advocates. Its Board of Directors voted to support HB 4838.

Under the bill, pet shops (redefined as brick-and-mortar establishments selling animals not bred at the establishment) could not sell, adopt, exchange, or transfer a dog, cat, or rabbit or offer a dog, cat, or rabbit for sale, adoption, exchange, or transfer. However, pet shops could showcase adoptable dogs, cats, or rabbits from the state's animal control and animal protection shelters.

HB 4838 has been referred to as the *Puppy Protection Act* or the *Humane Pet Store Bill*. These terms refer to the well-known fact that pet shops often acquire animals from large scale breeders, a/k/a puppy mills.

My testimony will focus on one argument often made by opponents to this bill, namely that large scale dog breeding operations are already regulated by the federal Animal Welfare Act and therefore this legislation is unnecessary.

The Animal Welfare Act (AWA) requires wholesale breeders and dealers who supply animals to pet stores, brokers, or research facilities to be licensed with USDA. Breeders and dealers are required to meet the minimum standards of humane animal care and treatment established by the AWA. It does not regulate retail pet shops. It does not pre-empt state or local regulation ⁱ.

Federal regulation is deficient in two significant ways.

- It establishes only minimum standards
- It is not adequately enforced ⁱⁱ
