Attorney General Nessel,

Nicole Glickman, MSW my psychologist suggested I reach out to your newly created Elder Abuse Task Force. I believe my mother Bonnie L. Luoma is a victim of Elder Abuse by the Oakland County Probate Courts under conservatorship of Jennifer Carney. I have been my mothers caregiver since returning from Florida seven years ago to assist her. I am not employed as I have been appointed legal guardian since my mother was made ward of the court May 18, 2018. All her finances, social security, pension and medical insurance are supposedly managed by the courts. I believe there has been a grave misuse of my mothers money.

My brother Brent D. Luoma does not have any responsibility as he haws frequently had her give him money, made loans in her name, physically mis handled her as well as his wife and is not allowed to have her alone. He has also beaten me several times and witnessed and the police have said it is a family dispute which they can do nothing about. I take my mother to lunch with him and he often says I wish you were dead.

As I have no job and am dependent on my mothers income to pay her bills etc. We are dependent on the court to give me money for my mothers needs.

On May 128, 2018 I was given co guardianship with Jennifer Carney as co guardianship. On that date my mother and I had \$20.00. I was instructed to be with my mother 24/7. Judge Kathleen Ryan was to be the presiding judge.

- 5/18/2018 In the hall (as the judge was running late and not there) Jennifer Carney said to call her office on May 21, 2018 and speak with Katie Burke to get some money.
- 5/21/2018 I called Katie Burke numerous times left messages. She finally called and said her phone and computer were not working and would call me later.
- 5/23/2018 I emailed to Katie Burke all my mothers information regarding payments due such as car payment, medical insurance, and other bills. She said that was not necessary as Jennifer Carney has everything but that was nice of you do I indicated how stressed I was I am as I do not feel I have any idea what to do. I was to do the right thing and not be any trouble so just tell me how to do this. Katie said when you make a purchase send receipts to me. At this time I was not informed I needed to take guardianship and conservator classes. In September Judy Muncy informed me I was to take classes. My mother was very sick and the weather did not permit later on. I have been on line and reviewed the booklet.
- 5/18/2018 Jennifer Carney in court ordered a land line and a life alert at my mothers home. I have asked Katie Burke many times when the land line and life alert will be ordered and she stated she would ask Jennifer Carney and also would ask when we would be getting any money.
- 5/24/2018 I sent numerous emails to Katie Burke and numerous phone calls asking for money.
- 5/29/2018 Katie Burke returned my call at 2@15pm and said they were closing for Memorial Day and would not be able to get me any money. We were dependent on borrowed money from my friends.
- 5/28/2018 I called Jennifer Carney's office spoke with Chrystal and she said Jennifer Carney was still reviewing statements and no funds would be disbursed. I explained I had no money for food, gas, hygiene products for my mother and no dogwood. She said if you can't afford a dog you need to get rid of it. My mother has had her dog for many years. She should never have to get rid of her dog.
- 6/05/2018 June 7, June 9 still no check and I was told they were probably lost in the mail.
- 6/11/2018 Katie Burke was to meet me at the Oakland County Probate Court at 1:30pm. I was given a check for \$59.84 for my mothers needs. This was all I received and it covered nothing.
- 6/19/2018 I received an AIM card for me to use for my mothers needs. It was not activated so it was unusable.
- 6/20/2018 My cousin Matthew tried calling Katie Burke left a message and the call was never returned.
- 6/21/2018 I mailed 2 of my mothers pension check to Jennifer Carney's office that had come to the house.
- 6/26/2018 My mothers car insurance was cancelled due to non payment
- 6/28/2018 I renewed my mothers license plate tabs that Katie Burke said I would be reimbursed for the next day and I was not.
- 7/03/2018 None of my mothers bills have been paid, condo association, DTE, Consumer Energy, AT&T, car payment and so on..
- 7/18/2018 I called Jennifer Carney's office again.
- 7/19/2018 I contacted Jennifer Carney's office that I had an incident with my brother and called the Wixom Police Department and was told to put a camera in the house or outside.
- 7/25/2018 Phone suspended due to non payment
- 8/15/2018 Internet suspended due to non payment
- 8/24/2018 Called Katie Burke for the \$284.00 bill for AT&T no response.
- 8/29/2018 my mother finally told me what my brother Brent and Sally sister in law did to her when she she was staying with . It was ohvsically very bad. I called Jennifer Carney to tell her what had hooeened Jennifer said "just wioe that out of

your head no need to bother about that now-end of conversation."

- 9/2018 I contacted Jennifer Carney's to say my mothers medical insurance (thru DTE Energy from my fathers employment) would be changing and they receive the new information to please let me know. Jennifer Carney replied "Lori wipe that right off you plate understood."
- 10/01/2018 An appointment with Dr. Steven Habel for my mother i found out there my mothers secondary insurance was canceled June 1, 2018 for on payment DTE. I called Jennifer Carney's office spoke with Judy minced asking why the insurance had not been paid. She said she had no information regarding the medical insurance to which I said yes I gave the information to wo Katie Burke. Judy Muncey said "I TOLD YOU I DO NOT HAVE THE INFORMATION DO YOU UNDERSTAND?" and hung up on me. I just wanted answers perhaps I was a little sharp.
- 11/08/2018 My mothers Cheverolet Equinox was due in September I told Katie Burke right from the beginning I was trading my car in and buying my mothers SUV at that time Jennifer Carney said hold off O said fine let me know when or I will wait till the lease is due. Judy Muuncey from Jennifer Carney's office called me and said 'RETURN YOUR MOTHERS CAR TODAY OR I WLL HAVE IT REPORTED STOLEN AND YOU WILL GO TO JAIL DO YOU UNDERTAND AND HUNG UP ON ME. I returned the car to Tony Whiteman at the dealership. Judy Muncey called Tony and was extremely rude to him.
- 11/21/22018 Judge Ryan took at least 4 breaks before our case. When it was our turn Judge Ryan stated I want everyone to understand Jennifer Carney will not go off this case her and I are very good friends does everyone understand we are good friends. Then Judge Ryan said she needed a break. When the break was over Judge Kathleen Ryan signed over that I was legal guardian. Jennifer Carney spoke up and said i don't feel Lori is capable of caring for her mother properly and Pauline Saroki spoke up and said I want to know where the \$50,000.00 is with that Judge Kathleen Ryan looked at me and screamed WHAT DID YOU DO WITH THE \$50,000.00 I said I did not take \$50,000.00 Judge Ryan then said WHEN I FIND OUT YOU TOOK THE THE \$50,000.00 i PERSONALLY WILL TAKE YOUR FILE AND YOU TO JESSICA COOPER. Judge Ryan threw her arms up in the air and said court is adjourned for the day I can't take anymore! She had a full courtroom. No one could believe her actions towards me. I have witness that saw the whole case David Loeffler. Others in the courtroom said they saw her outside drinking I have no idea i am saying what others said.
- About a week before Christmas my mother was so upset because she had no money my brother said have her call Pauline Saroki she did and twice Pauline hung up on my mother and myself when I said Bonnie Luoma would like to speak with you my mother aid who she was and said i need money for Christmas and hung up on her. I am sure she thinks I wanted the money no my mother wanted the money for her grand children. Now is that how you treat an elderly person NO.
- On May 30, 2019 I was granted full legal guardianship.
- On June 18, 2019 I went to Social Security explaining and showing them documents of which had not been paid. I was granted payee for my mother and the checks would be sent to my mother. Jennifer Carney intercepted the check and demanded

I sign over the check and she would have me removed as legal guardian. I showed proof to social security and they totally agreed with me. Jennifer Carney has threatened me so many times due to the fact I have found so many errors of what they are doing. I will not take these threats for something I have not done. I was doing this for my mother not myself yes I have some financial issues but that has nothing to do with my mother this is for my mother. My father and my mother worked hard for there money

One time in court Jennifer Carney stated "what the heck the woman can't even answer a phone. My mother was so humiliated she cried for 2 days over that. Not one person should be treated the way my mother has been treated its horrible.

My mother was in the hospital when this started and was very ill. According to Mr. Jeffrey Ehrlichman my mother had a breathing tube while he visited her she never had a breathing tube. Henry Ford Hospital policy is no legal decisions can be made in the hospital not one person was with my mother when Mr. Ehrlichman was there.

ACCUSATIONS MADE AGAINST ME

- I stalked the Judge Ryan
- I was double dipping how?
- I was incompetent to care for my mother
- I tampered with the mail
- I had stolen \$50,000.00
- I abused my mother
- Jennifer Carney stated my cell phone was attached to my mothers at&t bill no
- I purchased a camera for inside the house. Jennifer Carney stated i purchased the camera so I could leave my mother alone. As I stated before I purchased the camera because of issues with my brother. The Wxom police suggested I purchase one for evidence
- Jennifer Carney has not once shown any evidence of any of this.

To this day my mother does not have tv. Nor does she have money.
