COMMITTEE MEETING MINUTES

Wednesday, April 12, 2023 4:00 PM Room 352, House Appropriations, State Capitol Building

The House Appropriations Subcommittee on Joint Capital Outlay was called to order by Chair Price.

Representative Steckloff moved to adopt the meeting minutes from March 15, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4238 before the committee:

HB 4238 (Rep. Andrews)

A bill to make, supplement, and adjust appropriations for certain capital outlay projects for the fiscal year ending September 30, 2023; to provide for expenditure of the appropriations; and to prescribe certain conditions for the appropriations.

Austin Scott, from the House Fiscal Agency, testified before the subcommittee regarding the Michigan Natural Resources Trust Fund. Questions and discussion followed.

Senator McDonald Rivet made a motion to refer HB 4238 to the Committee on Appropriations, with recommendation. The motion prevailed 16-0-0:
