The House Committee on Agriculture was called to order by Chair Miller.

The Chair laid SB 148 and SB 149 before the committee:

SB 148 (Sen. Polehanki) A bill to amend 1969 PA 224, entitled "An act to

license and regulate dealers in and research facilities using dogs and cats for research purposes; and to repeal certain acts and parts of acts," by amending section 12 (MCL 287.392) and

by adding sections 11a and 12a.

SB 149 (Sen. Hertel) A bill to amend 1969 PA 224, entitled "An act to

license and regulate dealers in and research facilities using dogs and cats for research purposes; and to repeal certain acts and parts of acts," by amending the title and sections 1 and 7 (MCL 287.381 and 287.387) and by adding

section 8a.
